ELK MOUNTAIN-MEDICINE BOW RANGER STATION ROAD: A motion was made by Commissioner Jackson, Seconded by Cheesbrough and carried, whereby the County Clerk was instructed to publish a notice of Location of Public road in compliance with Article 3, Chapter 48, WCS 1945 as amended.

#### NOTICE OF LOCATION OF PUBLIC ROAD

TO WHOM IT MAY CONCERN: The Board of County Commissioners of Carbon County, Wyoming have decided to locate a road to be known as Elk Mountain-Medicine Bow Ranger Station Road, Carbon County, Wyoming.

Beginning at a point on the West line of the SE $\frac{1}{4}$  SE $\frac{1}{4}$  Section 20, Twp. 20 N., Range 80., 1010' N. of the SW Corner of said fraction; thence on a curve right to tangent southwesterly through said Section 20; thence southerly through sections 29 and 32 Twp. 20 N. Range 80 W; thence southerly through sections 5, 8, 17, 20, 21, 28 and 33 Twp. 19, N. Range 80 W.; thence southeasterly through sections 4, 9 and 16 Twp. 18 N., Range 80 W. to a point on the south line of said section 16, 1265 ft. more or less east of the south quarter corner thereof, said route more particularly shown on a map on file with the County Clerk of Carbon County.

The proposed location and width of right of way required are set forth in detail on a map on file with the County Clerk and may be examined at his office.

Any land owner or interested party desiring to raise any question with respect to the necessity of the taking of the land for road purposes shall do so by filing, within thirty days after the last publication of this notice, a petition in the District Court of the county in which the land is located. If no petition to raise the question of necessity is filed within the said thirty day period, the necessity shall be presumed and the question cannot later be raised.

All other objections thereto or claims for damages by reason thereof must be filed in writing with the County Clerk of said County before noon on the 8th day of May, A.D., 1957, or such road will be established without reference to such objections or claims for damages.
