

WATER COMMISSIONER: An application was received from James A. Gray of Encampment, Wyoming for position as Water Commissioner for District No. 7. A petition signed by the Beaver Creek Water users was attached to the petition, recommending the appointment of Mr. Gray. The Board of Commissioners approved the appointment and forwarded the application and petition to E. E. LeVasseur, Laramie, Wyo., State Hydrographer for his attention and the confirmation of the Governor.

There being no further business the meeting was adjourned until June 10, 1957, when the Commissioners will meet as a County Board of Equalization.
