BEEBE ACCESS ROAD: A motion was made by Jackson, seconded by Cheesbrough and carried whereby the following resolution was adopted.

Project SC-CFM 4759, Beebe Access Road, Carbon County

RESOLUTION

WHEREAS, the Board of Commissioners of Carbon County, Wyoming have laid out and constructed an access road

Commencing at a point on the centerline of the Lamont-Muddy Gap Road, Project No. DE-021-1(5), from which point the southwest corner of Section 15, T. 27 N., R. 89 W. of the 6th P.M. bears S. 24°40' a distance of 1139.9 feet, more or less;

thence running N. 76°43' E. a distance of 736.0 feet, more or less, to a point on the present highway No. 87 in the SW $\frac{1}{4}$ SW $\frac{1}{4}$  of said Section 15, and

WHEREAS, all the lands traversed by the above described road are unappropriated and unreserved public lands, and

WHEREAS, Section 2477 of the United States Revised Statutes provides that the right of way for the construction of highways over public lands, not reserved for public uses, is granted upon the establishment or construction of the highway in accordance with any of the modes prescribed or recognized by the laws of the State,

NOW THEREFORE BE IT RESOLVED, that the road as described above and shown in detail on a map on file with the County Clerk be declared established and a plat of same be placed in the road plat book with proper notations of the proceedings of said Board in relation to the establishment.
