ROAD ABANDONMENT - ROBBER'S GULCH ROAD AND OLD RAWLINS - SARATOGA ROAD.

A motion was made by Jackson, seconded by Cheesbrough and carried whereby the following Resolution was adopted.

#### R E S O L U T I O N

WHEREAS, the Board of County Commissioners decided to abandon the County Road known as the Old Rawlins - Saratoga Road and the County Road as the Robber's Gulch - Rawlins Road and,

WHEREAS, the Board of Commissioners proposed the abandonment of the above roads for the reason that said roads are no longer in use by the general public and,

WHEREAS, a Notice of Abandonment of the above mentioned roads was published in the Rawlins Daily Times on September 6, 13 and 20, 1958, this notice stipulated that all objections and claims for damages must be filed in writing with the County Clerk of said County, before noon on October 8, 1958 or such road will be abandoned with/reference to such objections or claims for damages, and

WHEREAS, the County Clerk sent registered letters to the land owners in the vicinity of these road abandonments, and

WHEREAS, a protest was received from Miss Katheryn Enberg of Saratoga, Wyoming objecting to the abandonment of the Robber's Gulch - Rawlins Road,

NOW THEREFORE BE IT RESOLVED, that the Board of County Commissioners hereby declare the Old Rawlins - Saratoga Road, and the Robber's Gulch - Rawlins Road, abandoned.
