COMMISSIONERS PROCEEDINGS
SPECIAL MEETING

The Board of Commissioners met at 1:00 P.M., all members present, George R. Salisbury, Jr., Chairman, to consider the petition of John A. Allen for private road over South Half of Section 26, Township 19 North, Range 83 West of the 6th P.M., as provided for in Section 48-331 W.C.S. 1945, the date of this hearing having been ordered by the Board of County Commissioners as 1:00 P.M., November 18, 1958.

A Notice of this hearing has been served on Roland R. Banzaf and Anna Banzaf, husband and wife, and Ravenscroft Cattle Co., by John Terrill, Sheriff of Carbon County, Wyoming.

Those present at this meeting were as follows: Roland and Anna Banzaf, Mr. & Mrs. John A. Allen, their Attorney, Harold M. Johnson, and County Attorney R. S. Lowe.

After due deliberation and consideration of the file and the statements of Mr. & Mrs. Banzaf and Mr. & Mrs. Allen, the Board of County Commissioners resolved and concluded the following:

- (1) That the applicant has complied with the law;
- (2) That such private road applied for is necessary; and
- (3) That three disinterested freeholders and electors of the County, namely, Noah Wolfard, Robert J. Johnson, and Paul Peryam, shall be appointed as viewers and appraisers to meet and report to the Board at its next regular session at 10:00 A.M., Feb. 4, 1959 at the Courthouse in Rawlins, Wyoming, and said Board will conduct hearing on confirmation of said report at the Courthouse in Rawlins, Wyoming at 2:00 P.M., on March 4, 1959.

SEMINOE DAM ROAD: A motion was made by Commissioner Jackson, Seconded by Cheesbrough and carried, whereby the County Clerk was instructed to publish a notice of Location of Public road in compliance with Article 3, Chapter 48, WCS 1945 as amended.

NOTICE OF LOCATION OF PUBLIC ROAD

SC-CFM 4771

TO WHOM IT MAY CONCERN: The Board of County Commissioners of Carbon County, Wyoming have decided to locate a road to be known as Seminole Dam Road, Carbon County, Wyoming.

Commencing at a point on the east-west center line of section 12, T. 22 N., R. 86 W. of the 6th P.M., said point bearing S86°35' W, a distance of 712.4 feet from the east one-quarter corner of section 12.

Thence in a northeasterly direction through sections 12, T. 22N., R. 86 W., section 6 & 7, T. 22 N. R. 85 W., sections 31, 30, 29, 20 17, 8, 5 & 4, T. 23N., R. 85 W., sections 33, 28, 27, 23, 14, 11, 12, 13 & 1, T. 24 N., R. 85 W., sections 7 & 6, T. 24N. R. 84 W., sections 31, T. 25 N., R. 84., section 36, T. 25 N., R. 85 W., sections 30, 19 & 20, T. 25 N. R. 84 W., to a point on the Bureau of Reclamation Road in the NW $\frac{1}{4}$, SE $\frac{1}{4}$ of section 20, T. 25 N., R. 84 W., said point bearing N 41°37' W, a distance of 3705 feet from the SW corner of section 20. T. 25 N. R. 84W.

The above described line being the center line of a right of way 100 feet in width.

The proposed location and width of right of way required are set forth in detail on a map on file with the County Clerk and may be examined at his office.

Any land owner or interested party desiring to raise any question with respect to the necessity of the taking of the land for road purposes shall do so by filing, within thirty days after the last publication of this notice, a petition in the District Court of the county in which the land is located. If no petition to raise the question of necessity is filed within the said thirty day period, the necessity shall be presumed and the question cannot later be raised.

All other objections thereto or claims for damages by reason thereof must be filed in writing with the County Clerk of said County before noon on the 7th day of January A. D., 1959, or such road will be established without reference to such objections or claims for damages.
