


A motion was made by Orton, seconded by Salisbury whereby the following Resolution was adopted.

WHEREAS, due to the non-payment of 1923 taxes on the minerals underlying the SW $\frac{1}{4}$ and the W $\frac{1}{2}$ SE $\frac{1}{4}$ of Section 32, in Township 22 North, Range 77 West, the County of Carbon acquired title to said minerals on the 11th day of July, 1924; that on the 7th day of July, 1927 the said mineral interest was sold to one James W. Wisda and on that date a County Commissioners' Deed was prematurely issued to the said James W. Wisda contrary to the statute then in effect;

LET IT THEREBY BE RESOLVED that a County Commissioners' Corrected Deed to the minerals underlying the SW $\frac{1}{4}$ and the W $\frac{1}{2}$ SE $\frac{1}{4}$ of Section 32 in Township 22 North, Range 77 West be issued to James W. Wisda and Frank M. Johnston.



- Barbara Bower, Home Demonstration Agent, effective October 1, 1959.


