BOYCE ADDITION - CITY OF RAWLINS: A motion was made, seconded and carried whereby the following resolution was adopted.

R E S O L U T I O N

A RESOLUTION OF THE BOARD OF COUNTY
COMMISSIONERS OF THE COUNTY OF CARBON,
STATE OF WYOMING, APPROVING THE "BOYCE
ADDITION" TO THE CITY OF RAWLINS:

WHEREAS, the Mayor and City Council of the City of Rawlins, Carbon County, Wyoming, at a regular meeting thereof on May 25, 1959, pursuant to the terms of 29-206 and 29-302 of the Wyoming Compiled Statutes of 1945 extended the City Limits of said City to include Boyce Addition thereto, and accepted and confirmed the dedication to public use of the streets and driveways laid out therein, and

WHEREAS, said Boyce Addition is platted over land adjacent to the City of Rawlins, Carbon County, Wyoming, and therefore pursuant to Section 29-1102 requires joint approval of the Board of County Commissioners and the legislative body of said City of Rawlins.

NOW THEREFORE, the Board of County Commissioners of the County of Carbon, State of Wyoming, pursuant to the terms of Section 29-1102 of the Compiled Statutes of 1945 do hereby approve the plat of the Boyce Addition to the City of Rawlins, Carbon County, Wyoming, submitted by William E. Boyce and Margaret M. Boyce the owners and proprietors thereof, which Addition is platted over land adjacent to said City and within one mile of the boundaries thereof and is described as follows, to-wit:

Beginning at a point on the South line of Sec. 8, T21N. R87W of the 6th P.M. which point lies S89°38'W, 1164.94° from the South $\frac{1}{4}$ corner of said Sec. 8; thence N011°W, 133.80°; thence N89°48'E, 35.55°; thence N14°54'E, 52.14°; thence S89°49W, 94.63°; thence N0°11W, 120.00°; thence S89°49'W, 650.33°; thence S20°48'W, 328.68° to a point on the South line of said Sec. 8, which point lies N89°38'E, 689.92° from the SW corner of said Sec. 8; thence N89°38'E, 812.03° to the point of beginning; said tract being situated in the SE $\frac{1}{4}$ of Sec. 8, T21N, R87W of the 6th P.M., Carbon County, Wyoming, said tract containing 5,209 acres, more or less.

BE IT FURTHER RESOLVED, that the Chairman of this Board be and he is hereby authorized, directed and empowered to endorse upon the official plat of said Boyce Addition to the City of Rawlins, Carbon County, Wyoming, the approval of this Board and that his signature be attested by the County Clerk under the official seal of the County.
