SEMINOE DAM ROAD SC-CFM 4771: A motion was made, seconded and carried whereby the following Resolution was adopted, to-wit:

RESOLUTION

WHEREAS, the Board of County Commissioners of Carbon County, Wyo., did on November 18, 1958 adopt a resolution declaring intent to establish road to be known as Seminoe Dam Road, described in notice of public road on record in the Office of County Clerk-Commissioner Record 11 on Page 121, and

WHEREAS, all land owners affected by said proposed road have been notified by registered mail, and

WHEREAS, the date of filing objections or claims for damages expired at noon on January 7, 1959, and

WHEREAS, no protests were received and all easements have been signed and properly recorded in the office of the County Clerk, and

WHEREAS, the Board of Commissioners decided to notify the Wyoming Highway Department in Cheyenne.

NOW THEREFORE, be it resolved; That the road described in Commissioner's Record 11 on Page 121 and shown in detail on map on file in the Office of the County Clerk of said County, be and is hereby declared established.

ORDER DECLARING A PRIVATE ROAD

WHEREAS, there was filed herein on October 7, 1958, by John A. Allen a petition for private road across the South Half (S $\frac{1}{2}$ ) of Section Twenty-six (26), Township Nineteen (19) North, Range Eighty-three (83) West, owned by Roland R. Banzhaf and Anna Banzhaf, and across the North Half (N $\frac{1}{2}$ ) of Section Thirty-five (35), Township Nineteen (19) North, Range Eighty-three (83) West of the Sixth (6th) Principal Meridian, owned by Ravenscroft Cattle Company, a co-partnership, and

WHEREAS, there was entered herein October 7, 1958, an order setting said petition for hearing at 1:00 P.M. on November 18, 1958, copies of said order having been served upon the said Roland R. Banzhaf, Anna Banzhaf

and Francis Ravenscroft as shown more fully by the Return of Service made and filed herein by the Sheriff of Carbon County, Wyoming, and

WHEREAS, at the time and place of said hearing the Board of County Commissioners of Carbon County, Wyoming, found that the applicant, John A. Allen, had complied with the laws respecting requests for private roads and that the private road as applied for was necessary, the Board then proceeded to appoint three disinterested freeholders and residents of Carbon County, Wyoming, Noah Wolfard, Robert J. Johnson and Paul Peryam, as viewers and appraisers of said private road to meet and report to the Board of County Commissioners respecting the location of said road and determine the amount of damages, if any, assessed by them and the person, or persons, entitled to such damages, and

WHEREAS, the viewers filed herein a report dated January 15, 1959, locating the private road together with their recommendations as follows:

1. Across the South  $\frac{1}{2}$  of Section 26, T. 19 N. R. 83 W. the present traveled way, 30' in width, west of and adjacent to the N. - S. cross fence beginning at a point on the south line of said Sec. 26, 15 ft., more or less, East of the  $\frac{1}{2}$  Cor. between said Sec. 26 and Sec. 35; thence North to a point 15 ft., more or less, east of the center of said Sec. 26, is hereby established a section of the Subject Private Road. This section is presently being used as means of ingress and egress to the County Road by aforesaid Roland R. Banzhaf, owner of the South  $\frac{1}{2}$  of said Sec. 26.
2. Across the North  $\frac{1}{2}$  of said Sec. 26 the petitioner will maintain a servicable road on his own premises parallel to and 30' from the N - S cross fence described above extended to the South bank of Pass Creek; thence the road shall follow the left bank of Pass Creek south-westerly to the present road and Bridge over Pass Creek; thence follow the present road north-easterly to a point 15 ft., more or less, W. of the  $\frac{1}{2}$  Cor. between said Sec. 26 and Sec. 23.
3. The petitioner shall install and maintain a servicable gate (or cattle guard & stock gate) in the division fence between his and Mr. Banzhaf's lands, designated Gate No. 1 on the accompanying plat.
4. If Mr. Banzhaf desires a gate (or cattle guard & stock gate) (Gate No. 2 on plat.) the same shall be installed and maintained by Mr. Banzhaf.
5. Gate No. 3 (or cattle guard & stock gate) shall be installed and maintained jointly at equal expense, by the petitioner and Mr. Banzhaf.
6. The subject Private Road shall extend directly South from its location on the line between Sec. 26 and Sec. 35 as hereinabove set forth, across Sec. 35, (owned by Francis J. Ravenscroft) to connect with the Overland-Elk Mountain County Road.
7. Damages.
  - a. Due to the fact that the land crossed by the Subject Private Road are presently used by the Banzhaf's as means of ingress and egress from their ranch home to the aforesaid county road, land damage incident on establishing this Private Road is almost nil; a token payment of \$25.00 therefor will be made by the petitioner to the Banzhaf's.
  - b. More or less intangible damage or annoyance will generate occasionally from the use of this road by others; as compensation the petitioner will pay to the Banzhaf's the sum of \$100.00.
  - c. As compensation for the right of way easement across lands in Sec. 35, the petitioner and Mr. Banzhaf will each pay the sum of \$1.00 to Francis J. Ravenscroft.

and

WHEREAS, Roland R. Banzhaf and Anna Banzhaf filed herein an objection and protest to the report of the viewers and appraisers and the said John A. Allen having filed herein a denial of said objection and protest and the Commissioners having on the 4th day of March, 1959, considered the report of the viewers and appraisers, and after consideration of the same, are satisfied that such report is just and the applicant having paid all costs of locating subject road and damages assessed by the viewers, the said Board of County Commissioners finds that the said report of the viewers and appraisers should, and the same is hereby, be confirmed and do hereby declare that the said road as described in the report of viewers be, and the same is hereby, declared to be a private road and it is hereby ordered to be recorded as such.
