MEDICINE BOW-KYLE ROAD - PROJECT S-0407 (1) - CARBON COUNTY

On April 18, 1960 the Board of County Commissioners adopted a Resolution to establish the above mentioned road. A notice of location was published on April 20th, 27th and May 24th and all land owners notified that objections and claims for damages must be filed in writing with the County Clerk on or before noon, June 7, 1960. The Board received claims for alterations and changes in pipe and power lines on the proposed road in the amount of \$15,359.67. In view of these high costs, the Board of County Commissioners have decided to abandon this project and that the State Highway Department and all land owners be notified of this action.

Thereupon the Board adjourned until the following day.

The Board received a request from Gertrude M. The Board approved this transfer.

COUNTY COMMISSIONER: Deputy County Attorney, Oscar A. Hall, was authorized and directed to investigate relative to the legal consequences of nonfeasance in office and neglect of statutory duty, if any, by Commissioner Pete Olsen, Jr., and to make full report to the Board.

MEMORIAL HOSPITAL BOARD: The Board received a letter from J. Reuel Armstrong recommending H. D. Peverley for re-appointment as a member of the Hospital Board, his term expires July 1, 1960.

George Allen of Rawlins was appointed to a five year term, commencing July 1, 1960 as a member of the Memorial Hospital Board in place of H. D. Peverley.

TRANSFER OF FUNDS FROM CASH RESERVE:

In compliance with Section 20-811 of the Municipal Budget Act, W.C. S. 1945, as amended in the Session Laws of 1947, a Notice of Hearing on the proposed transfer of funds from the Cash Reserve Fund was advertised May 13, 1960, as follows: County Sheriff \$3000.00, Clerk of District Court \$1600.00, Misd. General \$1000.00.

A motion was made by Orton and carried whereby the following resolution was adopted, to-wit:

RESOLUTION

WHEREAS, the above budgets have become depleted due to unanticipated costs.

IT IS HEREBY RESOLVED that the County Budget Officer and County Treasurer be authorized to transfer the above mentioned funds. The Board also decided to transfer \$10000 from the R & B Sinking fund to B-14 Road and Bridge Department.

ELECTION PRECINCTS: Due to the small number of voters in Kyle Dist.9 Prec.2, this precinct was consolidated with Medicine Bow Dist. 7 Prec. 1: Ft. Steele Dist. 5 Prec. 1 was consolidated with Sinclair Dist.17 Prec. 1, a petition from a majority of the voters requesting this consolidation was received by the Board.

THE ROSEBUD COAL SALES COMPANY presented a plat of the re-location of old highway No. 30 west of Hanna and a sketch of the proposed tipple site. No action was necessary as the road relocation did not involve any County road, the plat was filed in the office of the County Clerk.

PETITION: A copy of a petition from owners and lessees of property west of the Rawlins City limits was received from W. R. Daley. This petition was addressed primarily to the State Highway Department and the Bureau of Public Roads asking their consideration of a controlled access road. No action was taken at this meeting.




