
TAX ABATEMENT: Ruben Walters, Rawlins, Wyo., Account Veteran's Exemption, \$16.22.


APPOINTMENT: John Orton was appointed as a member of the Executive Committee of the Carbon County Chapter of the Wyoming State Historical Society.

R E S O L U T I O N

A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF THE COUNTY OF CARBON, STATE OF WYOMING, APPROVING H. LARSEN ADDITION TO THE CITY OF RAWLINS:

WHEREAS, the Mayor and City Council of the City of Rawlins, County of Carbon, State of Wyoming, at a regular meeting thereof on January 11, 1960, pursuant to the terms of Section 15-39 and Section 15-89 of the Wyoming Statutes 1957, extended the City Limits of said City to include the H. Larsen Addition thereto, and accepted and confirmed the dedication to public use the streets laid out therein, and

WHEREAS, said H. Larsen Addition is platted over land adjacent and contiguous to the City of Rawlins, Carbon County, Wyoming, and whereas section 34-114 of the Wyoming Statutes of 1957 requires joint approval of

the Board of County Commissioners and the legislative body of the said City of Rawlins.

NOW, THEREFORE, the Board of County Commissioners of the County of Carbon, State of Wyoming, pursuant to the terms of Section 34-114 of the Wyoming Statutes, 1957, do hereby approve the plat of the said H. Larsen Addition to the City of Rawlins, Carbon County, Wyoming, submitted by H. Larsen, Inc., a Wyoming Corporation, the owner and proprietor thereof, which Addition is platted over land adjacent to and within one mile of the boundaries thereof and is described as follows, to-wit:

A tract of land situated in the Southwest Quarter of the Southeast Quarter (SW $\frac{1}{4}$ SE $\frac{1}{4}$) of Section Eight (8), Township Twenty one (21) North, Range Eighty-seven (87) West of the 6th P.M., Carbon County, Wyoming, described as follows:
Beginning at the SE Con. of the SW $\frac{1}{4}$ SW $\frac{1}{4}$ SE $\frac{1}{4}$ Sec. 8, T. 21 N. 87 W, 6th P.M.; Thence N 0° 13' W, 661.30 Ft. to the NE con. of the SW $\frac{1}{4}$ SW $\frac{1}{4}$ SE $\frac{1}{4}$ of said Sec. 8; Thence S 89° 52' E, 658.20 Ft. to the SE Con. of the NE $\frac{1}{4}$ SW $\frac{1}{4}$ SE $\frac{1}{4}$ of said Sec. 8; Thence N 0° 11' W, 660.70 Ft. to the NE Con. of the NE $\frac{1}{4}$ SW $\frac{1}{4}$ SE $\frac{1}{4}$ of said Sec. 8; Thence N 89° 46' W, 1008.50 Ft. to a point on the North Line of the NW $\frac{1}{4}$ SW $\frac{1}{4}$ SE $\frac{1}{4}$ of said Sec. 8; Thence S 0° 13' E, 662.44 Ft. to a point on the South Line of the NW $\frac{1}{4}$ SW $\frac{1}{4}$ SE $\frac{1}{4}$ of said Sec. 8; Thence N 89° 52' W, 100 Ft. along the South Line of the NW $\frac{1}{4}$ SW $\frac{1}{4}$ SE $\frac{1}{4}$ of said Sec. 8; Thence S 0° 13' E, 661.71 Ft. to a point on the South Line of the SW $\frac{1}{4}$ SW $\frac{1}{4}$ SE $\frac{1}{4}$ of said Sec. 8; Thence S 89° 56' E, 450 Ft. to the point of Beginning; containing 22.148 acres.

BE IT FURTHER RESOLVED, that the Chairman of this Board be, and he is hereby authorized, directed and empowered to endorse upon the official plat of said H. Larsen Addition to the City of Rawlins, Carbon County, Wyoming, the approval of the board and that his signature be attested by the County Clerk under the official seal of Carbon County.
