COMMISSIONERS PROCEEDINGS

SPECIAL MEETING

The Board of Commissioners met at 10:00 A.M., Salisbury and Orton present, Olsen absent.

A motion was made by Orton, seconded by Salisbury and carried whereby the following Resolution was adopted.

R E S O L U T I O N

WHEREAS, the Board of County Commissioners of Carbon County, Wyoming, deem the public interest requires that a road be established to be known as the Medicine Bow-Kyle Road, Project S-0407 (1), described as follows:

Commencing at a point on the southerly right of way boundary of the presently existing U. S. Highway No. 30 in the $SE \frac{1}{4} NW \frac{1}{4}$ of Section 8, T. 22 N., R. 78 W. of the 6th P.M., Wyoming, which point bears N. $89^{\circ} 29' W.$ a distance of 1722.9 feet from a point which bears N. $17^{\circ} 44' W.$ a distance of 1913.3 feet from a point on the south boundary of said Section 8 from which the south quarter corner thereof bears N. $89^{\circ} 29' W.$ a distance of 529.0 feet;

Thence running in a southerly and southwesterly direction for a distance of approximately 5.337 miles through Sections, 8, 17, 20, 29, 30 and 31, T. 22 N., R. 78 W. and Section 36, T. 22 N., R. 79 W., all of the 6th P. M., Wyoming;

To a point of ending on the south boundary of Section 36, T. 22 N., R. 79 W. of the 6th P. M., Wyoming, from which the southeast corner of said Section 36 bears easterly a distance of 148.9 feet.

NOW, THEREFORE, BE IT RESOLVED, That the said Board do hereby initiate the procedure for the establishment of said road, and declare their intention to establish said road by following out the provisions of Section 24-37, Wyoming Statutes, 1957, not inconsistent therewith.

NOTICE OF LOCATION OF PUBLIC ROAD, MEDICINE BOW-KYLE ROAD, PROJECT NO. S-0407 (1) was adopted:

The Board of County Commissioners of Carbon County, Wyoming have decided to locate a road to be known as the Medicine Bow-Kyle Road, Project S-0407 (1) as described in above resolution.

The proposed location and width of right of way required are set forth in detail on a map on file with the County Clerk and may be examined at his office.

Any landowner or interested party desiring to raise any question with respect to the necessity of the taking of the land for road purposes shall do so by filing, within thirty days after the last publication of this notice, a petition in the District Court of the county in which the land is located. If no petition to raise the question of necessity is filed within the said thirty day period, the necessity shall be presumed and the question cannot later be raised.

All other objections thereto or claims for damages by reason thereof must be filed in writing with the County Clerk of said county before noon on the 7th day of June, A. D. 1960, or such road will be established without reference to such objections or claims for damages.
