IT IS HEREBY RESOLVED, THAT the County Budget Officer and County Treasurer be authorized to transfer the above mentioned funds. A motion was duly made and carried whereby the Road and Bridge Sinking Fund in the amount of \$10,000.00 was transferred to the Road and Bridge Budget No. 14.

Thereupon the Board adjourned until the following day.

DEPUTY SHERIFF: Byron T. Knowles was appointed as Deputy Sheriff for Snake River Valley in place of Lewis Waldron, resigned.

CARBON COUNTY MUSEUM BOARD: Kleber H. Hadsell, President of the Museum Board and other members presented a tentative budget for the maintenance of the museum for the 1961-62 fiscal year in the amount of \$1430.00.

LEASE: The Lease recorded in Book 389 at Page 150 between Carbon County and Art Boatright and M. R. Smith was renewed until April 1, 1962 for the sum of \$500.00.

There being no further business the meeting was adjourned.
