## COMMISSIONERS PROCEEDINGS

## SPECIAL MEETING

The Board met in Special Session at 10:00 A.M., to consider several road matters.

## SECTION 1B ENCAMPMENT-FRENCH-HOLMES ROAD AND SPUR TO ROUSE BRIDGE ACROSS THE NORTH PLATTE RIVER.

On September 6, 1961 the Board of County Commissioners decided to publish a Notice of Location of Public Road to be known as Section 1B Encampment-French-Holmes Road and Spur to Rouse Bridge Across the North Platte River. The date for receiving objections and claims for damages was set before noon on October 9, 1961.

A protest and claim for damages was received from Greenwood & Pattno, Attorneys for Millicent Sanger, Charles Albin and Kathryn Lynn Sanger for \$500.00 per acre for all lands taken and injury to the remaining lands not taken in the further sum of \$10,000.00.

Claim for damages was also received from John E. Rouse in the amount of \$500.00 per acre for all lands taken and \$20,000.00 damages to the remaining lands of John E. Rouse not so taken but affected.

The Board of Commissioners reviewed the claims for damages and in view of the exorbitant amounts claimed, a motion was made by Sullins seconded by Patton and carried whereby no action on this proposed road was tabled for further consideration.

## GRAVEL STOCK-PILING:

A motion was made by Sullins, seconded by Patton and carried whereby the following resolution was adopted.

## RESOLUTION

WHEREAS, the Board of County Commissioners of the County of Carbon, is desirous of taking advantage of the provisions of Chapter 99, and/or Chapter 118, Session Laws of Wyoming, 1951, by cooperating with the State Highway Commission of Wyoming in the improvement of county roads, the location and extent of which is as follows: Shirley Ridge Road 12 miles; Little Medicine Road 10½ miles; Cedar Ridge Road 5 miles; Saratoga - 10 mile - 5 miles; Jack Creek Road 7 miles; Baggott Bridge-Cow Creek 12 miles.


Stockpiling of 81,480 yards of gravel in various locations in Carbon County.

NOW, THEREFORE, be it resolved by said Board:

THAT the Board enter into a written agreement with said Commission covering said improvement in accordance with a contract therefor, now submitted to said Board by said Commission, which agreement is hereby approved and ordered filed in the office of the County Clerk of said county; that the chairmen of said Board and the County Clerk of said county be, and they are hereby authorized and directed to execute said contract on behalf of said Board.
