PUBLIC BUILDING BONDS: A motion was made by Commissioner Sullins, seconded by Patton and carried whereby the following resolution was adopted.

R E S O L U T I O N

WHEREAS, Notice of Sale of Carbon County, Wyoming, Public Building Bonds in amount of \$84,000 has heretofore been published in The Rawlins Daily Times, a newspaper of general circulation published in Rawlins, Carbon County, Wyoming, on November 18, 1961, and said Notice of Sale also having been published in The Wyoming Eagle, a newspaper printed and published at Cheyenne, Wyoming, the Capitol of the State of Wyoming on November 18, 1961; and

WHEREAS, said Notices of Sale have been duly and legally made pursuant to and in conformity with Section 18-249, Wyoming Statutes, 1957; and

WHEREAS, at the hour of 11:00 o'clock A.M. on December 5, 1961, at the Commissioners Room, Carbon County Courthouse, in Rawlins, Wyoming, the following sealed bids for said bonds were publicly opened and read:


WHEREAS, the Board of County Commissioners, Carbon County, Wyoming, considered said bids for the purchase of said Public Building Bonds and it appearing that the bid of The First National Bank of Rawlins and The Stock Growers National Bank of Cheyenne, Wyoming, is the best bid and at the lowest net effective rate of interest and is not less than par and accrued interest.

NOW, THEREFORE, BE IT RESOLVED that the bid of The First National Bank of Rawlins and The Stock Growers National Bank of Cheyenne, for \$84,000, Carbon County, Wyoming, Public Building Bonds dated January 1, 1962, to bear interest at the rate of 2.70% per annum payable January 1, and July 1, of each year and to mature on January 1, \$16,000 in the year 1963 and \$17,000 in each of the years 1964 to 1967, inclusive, be, and the same is hereby accepted.

BE IT FURTHER RESOLVED that George R. Salisbury, Jr., Chairman of the Board of County Commissioners, Carbon County, Wyoming, be, and he is hereby authorized, empowered and directed to sign, execute and accept the offer and bid dated December 5, 1961, of The First National Bank of Rawlins and The Stock Growers National Bank of Cheyenne.



R E S O L U T I O N

WHEREAS, the Board of County Commissioners of the County of Carbon is desirous of taking advantage of the provisions of Chapter 99, and/or Chapter 118, Session Laws of Wyoming, 1951, by cooperating with the State Highway Commission of Wyoming in the improvement of a county road, the location and extent of which is as follows:

Spring Creek Road

Section No. 2 of Project SC CFM 4284 3.745 Miles from a point on State Highway No. 230, southwesterly to beginning of Project No. 1 SC CFM 4284.


Grading, draining and 6" crushed gravel surface.


