WATER COMMISSIONER: Marvin Reed of Saratoga, Wyo. was confirmed as Water Commissioner for District #6 - Saratoga in place of Ronald Perue, who was unable to accept the appointment.

A motion was made by Sullins and carried whereby the following resolution was adopted.

R_E_S_O_L_U_T_I_O_N

WHEREAS, Carbon County, Wyoming, a Wyoming municipal corporation is the owner of a certain tract of unimproved land in the SE $\frac{1}{4}$ Section 18, Township 21 North, Range 87 West of the 6th Principal Meridian, which tract is adjacent to the corporate limits of the City of Rawlins, Wyoming, and

WHEREAS, it is to the best interest of said Carbon County, Wyoming, that said unimproved and adjacent tract should be annexed to the City of Rawlins, Wyoming, so that the same may be developed;

WHEREAS, said Carbon County, Wyoming, acting by and through the Board of Carbon County Commissioners must initiate legal proceedings pursuant to Section 15-365, Wyoming Statutes, 1957, to annex said unimproved tract to the City of Rawlins, Wyoming.

NOW THEREFORE BE IT RESOLVED that Oscar A. Hall, County and Prosecuting Attorney, Carbon County, Wyoming, be, and he is hereby authorized and instructed to initiate and undertake in behalf of Carbon County, Wyoming, any and all necessary legal proceedings to annex said unimproved tract of land to the City of Rawlins.
