SARATOGA BRIDGE: The Commissioners met at 10:00 A.M. with a delegation from Saratoga to discuss ways and means of replacing the bridge across the Platte River that was damaged so severely by ice that it had to be removed. It was decided by the Board that securing of right-of-way would be necessary before any appropriation could be made from County-Farm to Market Funds. The Board appointed Oscar Hall, County Attorney, and Attorneys John Crow and Eph U. Johnson to investigate this matter and report to the Board as soon as possible. The Board will also request the Wyoming Highway Department to include the bridge and right-of-way in the State Secondary Highway System.

COUNTY FAIR BOARD TREASURER'S BOND: The Board approved the bond of E. H. Breniman in the amount of \$2,000.00 as Treasurer of the County Fair Board for the period April 1, 1962 to April 1, 1963.

ABATEMENT: Ernest A. Martinez, Rawlins, Wyo., Abatement allowed in the sum of \$19.00, erroneous assessment.

There being no further business the meeting was adjourned.
