Carbon County Right-of-Way - Fort Steele

The Board approved the request of the MST&T Co. for a right-of-way encroachment covering a proposed buried telephone cable on the County right-of-way, SC-CFM 3783 through Sec. 23, 26 & 35, T. 21 N., R. 85 W., Carbon County, Wyoming, Project W-2-5006.

LIQUOR LICENSE: There being no protests entered, Liquor License No. 98 was granted to Mike Ryan, Lamont Bar, Lamont, Wyoming for a period of one year, 4-2-62 to 4-2-63, for the sum of \$300.00.

SHIRLEY RIDGE - UTAH MINING CAMP SPUR: The Board decided to locate the following described road and instructed the County Clerk to publish a Location Notice as follows:

NOTICE OF LOCATION OF PUBLIC ROAD

TO ALL TO WHOM IT MAY CONCERN: The Board of County Commissioners of Carbon County, Wyoming have decided to locate a road to be known as the SHIRLEY RIDGE - UTAH MINING CAMP SPUR.

Said road to be 100 Ft. in width, being 50 Ft. on each side of a center line beginning at point in the existing Shirley Ridge Road N. $44^{\circ}30'$ E., 400' from the W. $\frac{1}{4}$ Cor., Sec. 29, T. 28 N., R. 78 W; thence coursing North-easterly through Sections 29, 20, 21 and 28 and terminating at a point S. 30° W. 1395' from the N. E. Cor. Sec. 28; total length of proposed road 2.05 mi. more or less.

The proposed location and width of right-of-way required are set forth in detail on a map on file with the County Clerk and may be examined at his office.

All objections thereto or claims for damages by reason thereof must be filed in writing with the County Clerk of said County before noon on the 28 day of May, 1962, or such road will be established without reference to such objections or claims for damages.
