March 30, 1963 SPECIAL SCHOOL DISTRICT 3 ELECTION-INCREASE IN MILL LEVY: The Board of County Commissioners then proceeded to act as a canvassing board for the purpose of canvassing the returns of the Judges and Clerks of the Special School Election held on March 30, 1963, within School District No. 3, in the County of Carbon and State of Wyoming, at which election the Board of Trustees of said school district submitted to the qualified electors of said school district the following question:

"Shall the Board of Trustees of School District No. 3, in the County of Carbon and State of Wyoming, be authorized to make an additional annual levy of 4 mills for current expenses as permitted by Section 3 of Chapter 217, Session Laws of Wyoming, 1961, providing for an increase in allowable tax levies for school districts?"

The Board found from such canvas the following results:

The Chairman then declared that said election had carried in the affirmative in Ballot Box A and had also carried in the affirmative in Ballot Box B in said district; and that as a result of such election, the electors of said district had authorized the Board of Trustees of said district to levy the additional annual tax set forth in said question.

TRANSFER OF FUNDS FROM CASH RESERVE: In compliance with Section 20-811 of the Municipal Budget Act, W.C.S. 1945, as amended in the Session Laws of 1947. A Notice of Hearing on the proposed transfer of funds from the Cash Reserve Fund was advertised March 16, 1963, as follows: County Sheriff \$3500.00, District Court \$3000.00, Road & Bridge Dept. \$15000.00, Misc General \$3000.00, County Attorney \$500.00, Justice Court \$200.00, Elections \$1200.00.

A motion was made by Orton and carried whereby the following resolution was adopted, to-wit:

RESOLUTION

WHEREAS, the above budgets have become depleted due to unanticipated costs.

IT IS HEREBY RESOLVED that the County Budget Officer and County Treasurer be authorized to transfer the above mentioned funds.

Thereupon the Board adjourned until the following day.

April 3, 1963 The Board resumed its session Salisbury and Niland present, Orton absent.
