MUSEUM BOARD: Edith Daley was appointed to fill the unexpired term of P. E. Daley, term expiring 7-6-63.

SINCLAIR PIPE LINE CO. The Board granted a permit to install a Pipe Line under and across certain Carbon County Roads as shown on map in the office of County Clerk.

RAWLINS INSURORS: The Commissioners met with Harold E. Parks, W. Howard Unger, Jr. and Frank Maxson, representing USF and G Insurance Co. to discuss County insurance. It was decided to report again to the Board at a special meeting to be held June 10, 1963.

MENTAL HEALTH: Representatives of the Mental Health Board of Rawlins and Fred A. McCormack, MASW Director of Rock Springs, Sweetwater Counseling Service presented plans for a joint counseling service between Carbon and Sweetwater Counties. The proposed budget for Carbon County is \$6750.00. The Commissioners will take this into consideration at the budget hearing on June 10th, 1963.

Several road matters were disposed of, after which the Board adjourned.
