Thereupon, Commissioner John Orton introduced and moved the adoption of the following resolution, which was thereupon read in full and is as follows:

R E S O L U T I O N

WHEREAS, the City Clerk of the City of Rawlins, in the County of Carbon and the State of Wyoming, has transmitted a certified copy of an ordinance adopted and approved by the City Council of the City of Rawlins, on the 24 day of June, 1963, to the County Clerk for the Board of County Commissioners of Carbon County; and

WHEREAS, the Board of County Commissioners has determined, and does hereby determine, that it is necessary and for the best interest of the City of Rawlins, and the County, and its inhabitants, that a highway viaduct be established and constructed within the corporate limits of such City, and that a bonded indebtedness be contracted for that purpose in the amount of \$80,000.00 or so much thereof as may be necessary.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF CARBON COUNTY, STATE OF WYOMING:

Section 1. All action heretofore taken by the City Council of the City of Rawlins, the officers thereof, and the officers of Carbon County, directed toward submitting the question of issuing the negotiable, coupon general obligation bonds of the City in the aggregate principal amount of \$80,000.00, or so much thereof as may be necessary for the purpose of establishing and constructing a highway viaduct within the corporate limits of the City, be, and the same hereby is, ratified, approved and confirmed, including, without limiting the generality of the foregoing, the adoption by the City Council of an ordinance effecting such action on the 24 day of June, 1963, and all other action taken pursuant thereto.

Section 2. That the County Clerk shall give notice of the action hereby taken by transmitting to the Clerk of the City of Rawlins, Wyoming, for said City Council, a certified copy of this resolution.

Section 3. The officers of the County of Carbon be, and they hereby are, authorized and directed to take all action necessary or appropriate to effectuate the provisions of this resolution and Ordinance No. 300, Series 1963, passed and adopted on the 24 day of June, 1963 by the City Council of the City of Rawlins, Wyoming.


Section 4. All resolutions or parts thereof in conflict with this resolution are hereby repealed.

Section 5. If any section, paragraph, clause or provision of this resolution shall for any reason be held to be invalid or unenforceable, the invalidity or unenforceability of such section, paragraph, clause or provision shall not affect any of the remaining provisions of this resolution.

Section 6. By reason of the fact that said City is not properly or adequately supplied with highway viaduct facilities, it is hereby declared that an emergency exists, that this resolution is necessary to the immediate preservation of the public peace, health and safety, and that it shall be in full force and effect immediately after its adoption and approval.


Section 7. This resolution shall be entered on record in the minute book of the Board of County Commissioners, and the County Clerk is authorized and directed to carry out the provisions thereof.


