NOTICE OF LOCATION OF PUBLIC ROAD

Project No. S-0401(1)2 Colorado State Line - Riverside Road Carbon County

TO WHOM IT MAY CONCERN:

The Board of County Commissioners of Carbon County, Wyoming have decided to locate a road to be known as the Colorado State Line-Riverside Road Project S-0401(1)2.

Commencing at a point in Tract 69, Resurvey T. 13 N., R. 88 W. of the 6th P.M., Wyoming, which point bears N. 17° 37' E. a distance of 848 feet from the south boundary of Section 32 of said Resurvey from which the south east section corner of said Section 32 bears N. 89° 59' E. a distance of 1106.04 feet; thence running north-easterly a distance of approximately 4.88 miles through Tract 69, 67, 68, Section 33, Section 28, Tract 58, 57, Section 27, Tract 56, 55, Section 23, and Section 14 all of Resurvey T. 13N., R. 88W. of the 6th P.M., Wyoming. To a point of ending, N. 54° 40' E. a distance of 330 feet, more or less, from a point on the south boundary of the NE $\frac{1}{4}$ SE $\frac{1}{4}$  of Section 14 of said Resurvey from which the southwest corner of said NE $\frac{1}{4}$ SE $\frac{1}{4}$  bears westerly a distance of 175 feet, more or less.

The proposed location and width of right of way required are set forth in detail on a map on file with the County Clerk and may be examined at his office.

Any land owner or interested party desiring to raise any question with respect to the necessity of the taking of the land for road purposes shall do so by filing, within thirty days after the last publication of this notice, a petition in the District Court of the county in which the land is located. If no petition to raise the question of necessity is filed within the said thirty day period, the necessity shall be presumed and the question cannot later be raised.

All other objections thereto or claims for damages by reason thereof must be filed in writing with the County Clerk of said county before noon on the 8th day of January, A. D. 1964, or such road will be established without reference to such objections or claims for damages.
