HOG PARK ROAD: The Commissioners met with Forest Supervisor W. E. Augsbach to discuss a proposed road from Encampment to Hog Park. In a previous letter from Mr. Augsbach, he advised that the tentative plans are to make a location survey during the summer of 1963, to draw up road designs and plans during the winter of 1963-1964, and to contract the road construction during the summer of 1964 if Congress makes the necessary fund appropriations.

MEDICINE BOW RIVER GUARD STATION TO PASS CREEK ROAD: Mr. Jack Mahon, Jr. District Forest Ranger from Medicine Bow advised the Commissioners that proposed right-of-way number 1058 to improve East Fork Pass Creek Road has been abandoned in favor of a new proposed route from Medicine Bow River Guard Station across to Pass Creek which would greatly increase the efficiency with which the Forest Service could administer the Pass Creek timber sale and other work in the Pass Creek area.
