BAGGS CEMETERY DISTRICT: A motion was made by Niland, seconded by Salisbury and carried whereby the the following resolution was adopted.

R E S O L U T I O N

WHEREAS a Petition pursuant to Section 35-388, Wyoming Statutes, as amended, was presented and filed with the Board of County Commissioners, Carbon County, Wyoming, for the establishment of a proposed special cemetery district to be known as the BAGGS CEMETERY DISTRICT and which proposed district shall be composed of the following described lands FORMERLY KNOWN as the old SAND CREEK and BAGGS SCHOOL DISTRICTS:

Ranges 91, 92 and 93 West of the 6th P.M., Carbon County, Wyoming.

Townships 13, 14, 15, 16, 17, 18, 19 and all of Township 12 situated in Carbon County, Wyoming, and

WHEREAS, a public hearing on said Petition was held in the Commissioner's Room, Courthouse Building, Rawlins, Wyoming, on Wednesday, July 8, 1964, at 10:00 A.M., and

WHEREAS, Thirty (30) days have elapsed since the adjournment of said hearing and no written protests have been signed and filed to the Board of County Commissioners; and

WHEREAS pursuant to the law in such case made and provided the Board of County Commissioners shall order an election to be held within sixty (60) days after the expiration of the thirty day protest period upon the question of the organization and establishment of said special cemetery district.

NOW THEREFORE BE IT RESOLVED that a special election shall be held upon the question of the organization and establishment of the proposed BAGGS CEMETERY DISTRICT which district shall be composed of the following described lands formerly known as the OLD SAND CREEK and BAGGS SCHOOL DISTRICTS:

Ranges 91, 92 and 93 West of the 6th P.M., Carbon County, Wyoming.

Townships 13, 14, 15, 16, 17, 18, 19 and all of Township 12 situated in Carbon County, Wyoming.

BE IT FURTHER RESOLVED that an election on the question of the organization and establishment of the proposed BAGGS CEMETERY DISTRICT shall be held on Tuesday, October 6, 1964. The polls shall be open at 9 o'clock A.M. and close at 7 o'clock P. M. on said date at the following polling places within said proposed districts:

Baggs Parish House

BE IT FURTHER RESOLVED that notice of election stating the purpose, time and place thereof on said special election within said proposed Baggs Cemetery District shall be published in The Rawlins Daily Times on September 5, 12, 19, 26, 1964.

BE IT FURTHER RESOLVED that separate ballots shall be prepared for property owners and separate ballots for non-property owners in said proposed district. The qualifications of the non-property owning electors shall be the same as those provided for general elections. The qualifications for property owners shall be those required for general elections, in addition to which they shall be such property owners as shown by the last assessment roll preceding such election.
