## NOTICE OF GENERAL ELECTION PROCLAMATION

STATE OF WYOMING

In accordance with the provisions of Section 22-118.53-56, Wyoming Statutes, 1957, as amended, public notice is hereby given that a General Election will be held in the several polling precincts of the various election districts of Carbon County, Wyoming on Tuesday, November 3, 1964, for the purpose of voting for the following offices to-wit:

- One President of the United States
- One Vice President of the United States
- Three Presidential Electors
- One United States Senator
- One United States Representative
- Three Representatives in the State Legislature
- One Justice of the Supreme Court - 8 year term
- One Judge of the District Court - 6 year term
- One County Commissioner
- One Mayor for the City of Rawlins - 4 year term
- One City Councilman-City of Rawlins - Ward 1, 4 year term
- One City Councilman-City of Rawlins - Ward 2, 4 year term
- One City Councilman-City of Rawlins - Ward 3, 4 year term

Public notice is hereby given that at the General Election to be held in the State of Wyoming on November 3, 1964, the following proposed amendments to the Constitution of the State of Wyoming will be submitted to the electors of this State for adoption or rejection, to become valid as a part of said Constitution, if ratified by a majority of said electors.

PROPOSED CONSTITUTIONAL AMENDMENT NO. 1

Proposal to amend Section 26, Article XXI, of the Constitution of the State of Wyoming to read and provide as follows:

"The people inhabiting this state do agree and declare that they forever disclaim all right and title to the unappropriated public lands lying within the boundaries thereof, and to all lands lying within said limits owned or held by any Indian or Indian tribes, and that until the title thereto shall have been extinguished by the United States, the same shall be and remain subject to the disposition of the United States and that said Indian lands shall remain under the jurisdiction and control of the Congress of the United States; unless and to the extent the Congress of the United States authorizes the assumption of jurisdiction to the State of Wyoming; that the lands belonging to the citizens of the United States residing without this state shall never be taxed at a higher rate than the lands belonging to the residents of this state; that no taxes shall be imposed by this state on lands or property therein, belonging to, or which may hereafter be purchased by the United States, or reserved for its use. But nothing in this article shall preclude this state from taxing as other lands are taxed, any lands owned or held by any Indian who has severed his tribal relations, and has obtained from the United States or from any person, a title thereto, by patent or other grant, save and except such lands as have been or may be granted to any Indian or Indians under any acts of congress containing a provision exempting the lands thus granted from taxation, which last mentioned lands shall be exempt from taxation so long, and to such an extent, as is, or may be provided in the act of congress granting the same."

This proposed amendment to the Constitution of the State of Wyoming would permit the State legislature to enact laws assuming jurisdiction over Indian lands within the boundaries of the State in those areas where the Congress of the United States authorized the State to assume jurisdiction.

PROPOSED CONSTITUTIONAL AMENDMENT NO. 2

Proposal to repeal Sections 22 and 23 of Article 5 relating to justices of the peace and police magistrates and Section 5 of Article 19 relating to courts of arbitration, and to amend Section 1 of Article 5 of the Constitution of the State of Wyoming to read and provide as follows:

"Article 5, Section 1. The judicial power of the state shall be vested in the senate, sitting as a court of impeachment, in a supreme court, district courts, and such subordinate courts as the legislature may, by general law, establish and ordain from time to time."

Our State Constitution establishes and prescribes the jurisdiction of justice of the peace courts; also, it gives the Legislature authority to establish municipal and arbitration courts. This proposed amendment, if adopted, would eliminate all such courts from the Constitution and, instead, would give the Legislature the authority to establish the subordinate courts it deems best suited to our modern needs and provide for their jurisdiction and manner of functioning. In the meantime, the present system would continue in effect under existing statutes until changed by the Legislature.

PROPOSED CONSTITUTIONAL AMENDMENT NO. 3

Proposal to amend Section 6, Article XV, of the Constitution of the State of Wyoming to read and provide as follows:

"No incorporated city or town shall levy a tax to exceed twelve (12) mills on the dollar in any one year except for the payment of its public debt and the interest thereon."

The Constitution now provides that no city or town shall levy a tax of more than eight (8) mills on the dollar in any one year except for the payment of its public debt and the interest thereon. This proposed amendment would increase this limit from eight (8) mills to twelve (12) mills and would permit the levy by any city or town of a tax of up to twelve (12) mills on the dollar in any one year.

PROPOSED CONSTITUTIONAL AMENDMENT NO. 4

Proposal to amend Section 2, Article VIII, of the Constitution of the State of Wyoming to read and provide as follows:

"There shall be constituted a board of control, to be composed of the state engineer and superintendents of the water divisions; which shall, under such regulations as may be prescribed by law, have the supervision of the waters of the state and of their appropriation, distribution and diversion, and of the various officers connected therewith. Its decisions to be subject to review by the courts of the state; provided that the legislature may by general law assign duties relative to the enforcement of the laws of the State of Wyoming pertaining to water distribution to other personnel."

This proposed amendment to the Constitution of the State of Wyoming would permit the state legislature to enact laws assigning duties to persons other than the division superintendents for enforcement of the laws of Wyoming regarding distribution of waters of the state.


