BAGGS CEMETERY DISTRICT: A motion was made by Niland, seconded by Salisbury and carried whereby the following resolution was adopted.

R E S O L U T I O N

WHEREAS, the Baggs Cemetery District has been duly established as by law required pursuant to finding and Order of the Board of County Commissioners of Carbon County, Wyoming, and WHEREAS, pursuant to Section 35-391, Wyoming Statutes, 1957, within forty (40) days after the establishment of said district, an election of six (6) Trustees shall be held within said district at a time and place as designated by the Board of County Commissioners, and

WHEREAS, there shall be elected three (3) members to serve until the next succeeding district election hereafter, and three (3) members to serve until the second succeeding district election and until their successors are elected and qualified, and

WHEREAS, it is the legal duty of the Board of County Commissioners of Carbon County, Wyoming, to designate polling places and the date and hours of such election for Trustees of the said Baggs Cemetery District, and

WHEREAS, notice of said election shall be given by publication once weekly in a local newspaper in said Carbon County for not less than two (2) weeks preceding such election.

NOW THEREFORE BE IT RESOLVED that a special election of Trustees to serve the Baggs Cemetery District shall be held on November 21, 1964, at the Parish House, Baggs, Wyoming, between the hours of 9:00 a.m. and 7:00 p.m. Be it further resolved that three members or trustees shall be elected to serve until November 8, 1966; and three members or trustees shall be elected to serve until November 5, 1968, or until their successors are duly elected and qualified.

BE IT FURTHER RESOLVED that notice of said election shall be given by publication once weekly in The Rawlins Daily Times, a newspaper printed and of general circulation in Carbon County, Wyoming, and that said publication shall be made on November 13, 20, 1964.

BE IT FURTHER RESOLVED that the judges and clerks of such election shall be the same judges and clerks duly appointed to serve at the General Election and said judges and clerks shall receive no additional compensation therefor.
