POLL TAX: A motion was made by Orton, seconded by Niland and carried, authorizing the County Assessor to proceed with the collection of Poll Tax for 1964, in compliance with Section 39-236 Wyoming Statutes 1957.

UNION PACIFIC RAILROAD COMPANY - RIGHT OF WAY LEASE. A motion was made by Orton, seconded by Niland and carried, whereby the following resolution was adopted.

WHEREAS, UNION PACIFIC RAILROAD COMPANY has tendered to COUNTY OF CARBON, STATE OF WYOMING, an agreement extending to and including February 28, 1969, the term of contract dated August 9, 1934, granting to the County certain rights for highway purposes in portions of the Railroad Company's right of way in Carbon County, Wyoming; said agreement being identified as Union Pacific Railroad Company's C. D. No. 9221-I; and

WHEREAS, the Board of County Commissioners of the County of Carbon has said proposed agreement before it and has given it careful review and consideration; and

WHEREAS, it is considered that the best interests of said County of Carbon, State of Wyoming, will be subserved by the acceptance of said agreement;

THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF CARBON COUNTY, STATE OF WYOMING:

That the terms of the agreement submitted by Union Pacific Railroad Company as aforesaid be and the same hereby are accepted in behalf of Carbon County, State of Wyoming;

That the Chairman of the Board of County Commissioners of said County hereby is authorized, empowered and directed to execute said agreement on behalf of said County, and that the County Clerk hereby is authorized and directed to attest said agreement and to attach to each duplicate original of said agreement a certified copy of this resolution.




