RESOLUTION

BE IT RESOLVED by the Board of the County Commissioners of the County of Carbon, Wyoming, at a regular meeting held at Rawlins, Carbon County, Wyoming, on the 8th day of September, 1965, whereas the said Board has deemed the public interest require the establishment of a County Highway as hereinafter described across certain lands owned by the Sanger Ranches and Millicent Sanger and Charles Sanger, Jr., and Katherine Sanger:

1. That according to the provisions of Section 24-43, Wyoming Compiled Statutes of 1957, the said Statutory procedure for the establishment of a County Highway is hereby initiated, the point of commencement of said Highway being at a point which bears South along the N-S center line of Section 28, T. 15 N., R. 82 W., 6th P.M., Carbon County, Wyoming, a distance of 1000' \pm from the N $\frac{1}{4}$ corner of said Section 28, said point being at the center line of an existing road way:

thence traversing Southwesterly through Sections 28, 27, 34, 35 and 36, said Township and Range;

thence continuing in an easterly direction through Section 1, T. 14N., R. 82 W.;

thence continuing in a northeasterly direction through Sections 33 and 34, T. 15 N., R. 81 W., to a point of termination which is on the N-S center line of Section 34, T. 15 N., R. 81 W., said point also being on the center line of said existing road way, said point bears South along said centerline of Section 34, a distance of 2100' \pm from the North $\frac{1}{4}$ corner of said Section 34, T. 15N., R. 81 W., and

2. That Allen W. Mace is hereby appointed as viewer to examine into the expediency of the proposed road, and the establishment as heretofore set out, and to report to the said Board of the County Commissioners immediately; and

3. That the County Clerk of Carbon County shall, after the report of the viewer aforesaid is made to the said Board of the County Commissioners, cause notice to be given of the proposed location of the said road or County Highway, as set forth in Section 24-52, Wyoming Statutes, 1957; and

4. That Allen W. Mace, County Surveyor of Carbon County, is hereby authorized and directed to make an accurate survey of the road location across the lands described, in the place where the said road presently crosses the said lands, and to plat and record the said survey in the book provided by the County for such purpose, and file a copy of said plat and notes of such survey in the office of the County Clerk.
