A motion was made and carried whereby John Orton was elected temporary chairman of the new Board. A motion was then made by Niland, seconded by Salisbury that John Orton be elected permanent chairman of the Board of Commissioners for a two year term, expiring January 3, 1967. The Bond of John Orton was presented and approved in the amount of \$1000.00.

POLL TAX: The County Assessor was authorized to proceed with the collection of Poll Tax for the year 1965, in compliance with Section 39-326 W.C.S. 1957.

OFFICIAL COUNTY NEWSPAPER: The Rawlins Daily Times was appointed as the official publication and newspaper for a two year term expiring January 3, 1967.

WELFARE BOARD: George R. Salisbury, Jr. was appointed as a member of the Carbon County Welfare Board for a two year term expiring January 3, 1967.

COUNTY SURVEYOR: Allen W. Mace was appointed County Surveyor for a two year term expiring January 3, 1967.

DEPUTY COUNTY CORONER: Craig Carmain was appointed Deputy County Coroner for a two year term expiring Jan. 3, 1967 in place of Paul H. McKelvey who resigned. The Bond for Craig Carmain in the amount of \$1000.00 was approved by the Board.

Thereupon the Board adjourned until the following day.

January 6, 1965 The Board resumed its session Orton, Salisbury and Niland present, John Orton chairman.

TRANSFER OF FUNDS FROM CASH RESERVE:

In compliance with Section 20-811 of the Municipal Budget Act. W. C. S. 1945, as amended in the Session Laws of 1947, A notice of Hearing on the proposed transfer of funds from the Cash Reserve Fund was advertised December 15, 1964, as follows: Elections \$2000.00.

A motion was made by Orton and carried whereby the following resolution was adopted, to-wit:

Allen W. Mace, Rawlins, County Surveyor bond in the amount of \$1000.00 approved, expires January 3, 1967.

CERTIFICATE OF PURCHASE No. 4097 was assigned to Sam D. Morgan, of Dixon on the $\frac{1}{2}NE\frac{1}{4}$ Sec. 13 T 18 R 84 for the sum of \$27.40.

LIMITED RETAIL LIQUOR LICENSE No. 115 was granted to Willow Hills Stage Stop for the period January 6, 1965 to January 6, 1966 for the sum of \$100.00, being located in Part of Sec. 16, T 23 R 88 W, about 14 miles north of Rawlins, R. L. Douglas owner. The application for this license was published on December 8, 15, 22 & 29, 1964 in the Rawlins Daily Times and no protests were entered. The Willow Hills Stage Stop is affiliated with the National Muzzle Loading Rifle Association of Shelbyville, Ind.
