The Board of Commissioners met with the Carbon County Library and Museum Boards and it was agreed the Courthouse Community Room be converted into a Museum and that future public meetings would have to be scheduled in the Jeffrey Memorial Center.

CARBON COUNTY LAW LIBRARY: The Commissioners entered into a contract with the Carbon County Bar Association for establishment of a County Law Library and the contract was placed on file in the office of the County Clerk. It was also agreed that the room on the second floor now used by the Carbon County Museum would be converted into a Law Library.

COUNTY FAIR BOARD: The Board re-appointed Phil Espy as a member of the County Fair Board. The present term expired 2-2-65 and the new term will run until February 2, 1970.

There being no further business the meeting was adjourned.
