COUNTY LIBRARY BOARD: Mrs. Leeland U. Grieve, Rawlins was reappointed as a member of the County Library Board for the period June 2, 1965 to June 2, 1968.

SARATOGA - STORER RANCH ROAD: A motion was made by Niland, seconded by Orton and carried whereby the following resolution was adopted.

RESOLUTION

WHEREAS, the Board of County Commissioners of the County of Carbon is desirous of taking advantage of the provisions of Section 24-38, W.S. 1957, and/or Chapter 118, Session Laws of Wyoming, 1951, by cooperating with the State Highway Commission of Wyoming in the improvement of a county road, the location and extent of which is as follows:

Starting at a point at the end of Project S-0408 (2) and proceeding in a East South East direction for approximately 1.5 miles within the following described lands: S $\frac{1}{2}$  Sec 12, T 17 N, R 84 W, and S $\frac{1}{2}$  Sec 7 & N $\frac{1}{2}$  Sec 18, T 17 N, R 83 W. Carb n County, State of Wyoming.

NOW, THEREFORE, be it resolved by said Board:

THAT the Board enter into a written agreement with said Commission covering said improvement in accordance with a contract therefor, now submitted to said Board by said Commission, which agreement is hereby approved and ordered filed in the office of the County Clerk of said county; that the chairman of said Board and the County Clerk of said county be, and they are hereby authorized and directed to execute said contract on behalf of said Board.




