LIQUOR DEALERS: The Board met with several City and County liquor dealers to discuss the four Sunday opening dates allowed under Chapter 21, Session Laws, Wyoming 1965. REGULAR MEETING

The Board of Commissioners met at 10:00 A. M., John Orton, Chairman, John Niland and George R. Salisbury, Jr. all present. The minutes of meetings held April 5th and 6th were read and approved.

A motion was made by Niland and seconded by Salisbury and carried whereby the following resolution was adopted.

R E S O L U T I O N

A RESOLUTION OF THE BOARD OF THE COUNTY COMMISSIONERS OF THE COUNTY OF CARBON, STATE OF WYOMING, APPROVING KOREIN TEMPLE ADDITION TO THE CITY OF RAWLINS:

WHEREAS, the Mayor and City Council of the City of Rawlins, Carbon County, Wyoming, at a regular meeting thereof on April 12, 1966, pursuant to the terms of Section 15-1-69, Wyoming Statutes, 1957, C. 1965, extended the City Limits of said City to include Korein Temple Addition thereto, and accepted and confirmed the dedication to public use of the streets laid out therein, and

WHEREAS, said Korein Temple Addition is platted over land adjacent to the City of Rawlins, Carbon County, Wyoming and therefore pursuant to Section 1, Chapter 196, Session Laws of Wyoming, 1965, requires joint approval of the Board of the County Commissioners and the legislative body of said City of Rawlins.

NOW, THEREFORE, the Board of the County Commissioners of the County of Carbon, State of Wyoming, pursuant to the terms of Section 1, Chapter 196, Session Laws of Wyoming, 1965, do hereby approve the plat of Korein Temple Addition to the City of Rawlins, Carbon County, Wyoming, submitted by Korein Temple Holding Company, a Wyoming corporation, the owner and proprietor thereof, which Addition is platted over land adjacent to said City and within one mile of the boundaries thereof and is described as follows, to-wit:

A tract of land located in the Northwest Quarter of the Southwest Quarter ( $NW\frac{1}{4}SW\frac{1}{4}$ ) and Southwest Quarter of the Northwest Quarter ( $SW\frac{1}{4}NW\frac{1}{4}$ ) of Section Nine (9), Township Twenty-one (21) North, Range Eighty-seven (87) West of the Sixth (6th) P. M. in Carbon County, Wyoming, and further described as follows:

Beginning at the Northeast Corner of the School Land, said point of beginning being on the East line of the Northwest Quarter of the Southwest Quarter ( $NW\frac{1}{4}SW\frac{1}{4}$ ) of said Section Nine (9), and bears North  $0^{\circ} 04'$  West, 660.00 Feet from the Southwest Corner of the Northwest Quarter of the Southwest Quarter ( $NW\frac{1}{4}SW\frac{1}{4}$ ) of said Section Nine (9);

Thence North  $0^{\circ} 04'$  West, 662.10 feet to the Northeast Corner of the Northwest Quarter of the Southwest Quarter ( $NW\frac{1}{4}SW\frac{1}{4}$ ) of said Section Nine (9);

May 3, 1966

Thence North  $0^{\circ} 08'$  West, 174.47 feet along the East line of the Southwest Quarter of the Northwest Quarter ( $SW_4^1 NW_4^1$ ) of said Section Nine (9) to the intersection of U.S. Highway No. 287 right-of-way;

Thence Southwesterly 815.86 feet along the Highway right-of-way following a curve to the right having a radius of 4683.6 feet and a  $1^{\circ} 13'$  Degree of Curvature, to the end of the curve;

Thence South  $50^{\circ} 14'$  West, 408.7 feet along the Highway right-of-way to the North line of the School Land;

Thence South  $89^{\circ} 55'$  East, 894.30 feet along the North line of the School Land to the point of beginning;

Said tract containing 8.070 acres, more or less.

BE IT FURTHER RESOLVED, that the Chairman of this Board be and he is hereby authorized, directed and empowered to endorse upon the official plat of said Korein Temple Addition to the City of Rawlins, Carbon County, Wyoming, the approval of this Board and that his signature be attested by the County Clerk under the official seal of the County.

The Board of Commissioners met at 10:00 A. M., John Orton, Chairman and George R. Salisbury, Jr. present and John Niland absent. The minutes of meetings held May 3rd and 4th were read and approved.

The following Election Districts and Polling Precincts were established for the coming two year period.

ELECTION DISTRICTS  
&  
POLLING PRECINCTS

In compliance with Section 22 - 8 Wyoming Statutes of 1957, the Board of Carbon County Commissioners does hereby establish the following ELECTION DISTRICTS AND POLLING PRECINCTS.

It shall be understood that the described lines between points at which bearing changes occur shall intend to follow either the line called for in each specific case; or section, township, range and city and county boundary lines.

X DISTRICT 1 - RAWLINS

All that area encompassed by the following closed perimeter description shall be known as ELECTION DISTRICT NO. 1:

Beginning at a point which is the intersection of the UPRR and tenth street; thence Northerly along 10th Street, including the Chrisman Block, to an intersection with Buffalo Street; thence easterly along Buffalo Street and the projection thereof to an intersection with the projected South line of Sawtell's First Addition; thence east along said Sawtell's Addition south boundary and the projection thereof to an intersection of the east city limits; thence south along the east city limits to the south city limits; thence West to the West city limits; thence North along West city limits to an intersection with the U. P. R. R.; thence easterly along the U. P. R. R. to the original point of beginning.

DISTRICT 2 - RAWLINS

All that area encompassed by the following closed perimeter description shall be known as ELECTION DISTRICT NO. 2:

Beginning at a point which is the intersection of the Buffalo Street and Seventh Street; thence East-erly along the Buffalo Street and the projection thereof to an intersection with the projected south line of Sawtell's First Addition; thence east along said Sawtell's Addition south boundary and the projection thereof to an intersection of the East city limits; thence north along the east city limits to the north city limits; thence west to an intersection of the north city limits and a projection of Seventh Street; thence Southerly along said projection and Seventh Street, excluding the Ford Garage at Seventh & Spruce Streets, to the original point of beginning.

DISTRICT 3 - RAWLINS

All that area encompassed by the following closed perimeter description shall be known as ELECTION DISTRICT NO. 3:

Beginning at a point which is the intersection of Buffalo Street and Seventh Streets; thence northerly along Seventh Street and the projection thereof to an intersection with the north city limits; thence west along said city limits to an intersection with the west city limits; thence south along said west city limits to an intersection with the U. P. R. R.; thence easterly along said U. P. R. R. to an intersection with Tenth Street; thence northerly, excluding the Chrisman Block, to an intersection with Buffalo Street; thence easterly along Buffalo Street to the original point of beginning.

DISTRICT NO. 4 - LAMONT

All that area encompassed by the following closed perimeter description shall be known as ELECTION DISTRICT NO. 4:

Beginning at a point on the West line of Carbon County which is the S.W. corner of T. 25N., R. 89W.; thence E. along the S. line of T. 25 N. to the original channel of the North Platte River; thence along said river channel to the N. line of Carbon County; thence along the N. line of Carbon County to the N.W. corner of Carbon County; thence along the W. line of Carbon County to the original point of beginning.
