A motion was made by Niland and seconded by Salisbury and carried whereby the following resolution was adopted, to-wit:

RESOLUTION

WHEREAS, the above budgets have become depleted due to unanticipated costs.

IT IS HEREBY RESOLVED that the County Budget Officer and County Treasurer be authorized to transfer the above mentioned funds.

MEDICINE BOW - KYLE ROAD, F. A. S. ROUTE 0407: The Board approved the removal of F. A. S. Route 0407, Medicine Bow-Kyle road from the approved Federal Aid Secondary System as shown on the map on file in the office of the County Clerk. (Approximately 12.8 miles.)

HANNA - ELK MOUNTAIN ROAD: The Commissioners approved the extension of approved F. A. S. Road #0404 as submitted by the Wyoming Highway Department and shown on a map on file in the office of the County Clerk.

Thereupon the Board adjourned until the following day.

SAGE CREED ROAD: A motion was made by Niland, seconded by Salisbury and carried whereby the following resolution was adopted

R E S O L U T I O N

WHEREAS, the Board of County Commissioners of the County of Carbon is desirous of taking advantage of the provisions of Chapter 99, and/or Chapter 118, Session Laws of Wyoming, 1951, by cooperating with the State Highway Commission of Wyoming in the improvement of a county road, the location and extent of which is as follows:

1. Sage Creek Road from end of existing oil south for approximately 15 miles to Middlewood Hill.
2. That said construction work shall consist of the following: Crushing and stockpiling of crushed material at various locations along existing county road.

NOW, THEREFORE, be it resolved by said Board:

THAT the Board enter into a written agreement with said Commission covering said improvement in accordance with a contract therefor, now submitted to said Board by said Commission, which agreement is hereby approved and ordered filed in the office of the County Clerk of said county; that the chairman of said Board and the County Clerk of said county be, and they are hereby authorized and directed to execute said contract on behalf of said Board.

WHEREAS, notice of a public hearing on such budget, together with the summary of said budget, was published in the Rawlins Daily Times, a legal newspaper published and of general circulation in the county on the 21st day of July, 1966 and

WHEREAS, a public hearing was held on such budget at the time and place specified in said notice, at which time all interested parties were given an opportunity to be heard; and

WHEREAS, following such public hearing certain alterations and revisions were made in such proposed budget, all of which more fully appear in the minutes of this Board.

NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners that the county budget, as so revised and altered, be adopted as the official county budget for the 1966-1967 fiscal year ending June 30, 1967.
