AMENDED VALLEY VIEW ACRES ADDITION TO THE TOWN OF SARATOGA: A motion was made,seconded and carried whereby the following resolution was adopted.

R E S O L U T I O N

A RESOLUTION OF THE BOARD OF THE COUNTY COMMISSIONERS OF THE COUNTY OF CARBON, STATE OF WYOMING, AP-PROVING THE "AMENDED VALLEY VIEW ACRES ADDITION" TO THE TOWN OF SARATOGA

WHEREAS, the Mayor and Town Council of the Town of Saratoga, Carbon County, Wyoming, at a regular meet-ing thereof on August 2, 1966, pursuant to the terms of Section 15-1-69, Wyoming Statutes, 1957, C. 1965, and Sub-Section (10) of Section 15-1-3, Wyoming Statutes, 1957, C. 1965, extended the Town Limits of said Town to include the Amended Valley View Acres Addition thereto, and accepted and confirmed the dedication to public use of the streets and alleys laid out therein, and

WHEREAS, said Amended Valley View Acres Addition is platted over land adjacent to the Town of Saratoga, Carbon County, Wyoming, and therefore pursuant to Section 1, Chapter 196, Session Laws of Wyoming, 1965, requires joint approval of the Board of the County Commissioners and the legislative body of said Town of Saratoga.

NOW, THEREFORE, the Board of the County Commissioners of the County of Carbon, State of Wyoming, pursuant to the terms of Section 1, Chapter 196, Session Laws of Wyoming, 1965, do hereby approve the plat of the Amended Valley View Acres Addition to the Town of Saratoga, Carbon County, Wyoming, submitted by Charles L. "Roy" Welton and Helen M. Welton, husband and wife, of Saratoga, Carbon County, Wyoming; Peter E. Hager and Shella A. Hager, husband and wife, of Sheridan, Sheridan County, Wyoming; Lynn A. Brown and Phyllis A. Brown, husband and wife, of Saratoga, Carbon County, Wyoming; and, Robert J. Johnson and Victoria A. Johnson, husband and wife, of Elk Mountain, Carbon County, Wyoming, each in his and her own right, the owners and proprietors thereof, which Addition is platted over land adjacent to said Town and within one mile of the boundaries there-of and is described as follows, to-wit:

A Tract of land in the Southwest Quarter of the Southeast Quarter (SW $\frac{1}{4}$ SE $\frac{1}{4}$ ) and the Southeast Quarter of the Southeast Quarter (SE $\frac{1}{4}$ SE $\frac{1}{4}$ ) of Section Fourteen (14), Township Seventeen (17) North, Range Eighty-four (84) West of the Sixth (6th) P. M. described as follows:

Beginning at the South Quarter Corner of Section Fourteen (14), Township Seventeen (17) North, Range Eighty-four (84) West and running North 00° 18' East, 1311.20 Feet to the West Sixteenth Corner of the Southeast Quarter (SE $\frac{1}{4}$ ) of Section Fourteen (14), Township Seventeen (17) North, Range Eighty-four (84) West; Thence South 88° 59' East, 1432.90 Feet to the Northwest Corner of Tract Seven (7); Thence South 88° 53' East, 145.00 Feet to the Southeast Corner of Tract Seven (7); Thence South 15° 13' East, 1083.40 Feet to the Northeast Corner of Tract Ten (10); Thence North 88° 53' West, 241.40 Feet to the Northwest Corner of Tract Ten (10); Thence South 00° 18' West, 117.50 Feet to the South-west Corner of Tract Ten (10); Thence North 88° 53' West, 1686.00 Feet to the South Quarter Corner of Section Fourteen (14), Township Seventeen (17) North, Range Eighty-four (84) West and to the point of beginning; containing 52.46 acres of land, more or less.

BE IT FURTHER RESOLVED, that the Chairman of this Board be and he is hereby authorized, directed and empowered to endorse upon the official plat of said Amended Valley View Acres Addition ot the Town of Saratoga, Carbon County, Wyoming, the approval of this Board and that his signature be attested by the County Clerk under the official seal of the County.
