PLANNING COMMISSIONS AND TOWN COUNCILS OF THE TOWNS OF ELK MOUNTAIN, ELMO AND HANNA

Robert S. Lowe, Attorney, representing the Towns of Elk Mountain, Elmo and Hanna, appeared before the Board and discussed with the Board the creation of an Area Planning Commission in conjunction with the Planning Commissions of each respective Town and also there was presented to the Board the minutes of the meetings of the Area Planning Commission, as well as the minutes of the Planning Commissions and Town Councils of the Towns of Elk Mountain, Elmo and Hanna regarding plans for area water and sewer development and the minutes of the Carbon County Planning Commission. After discussion was had, it was regularly moved by Commissioner George R. Salisbury, Jr., and seconded by Commissioner John Niland that the following resolution be adopted:

R E S O L U T I O N

"RESOLVED, that the Area Planning Commission comprised of representatives of the Towns of Elk Mountain, Elmo and Hanna, to adopt plans for water and sewer development in the area encompassed by said communities and areas immediately adjoined thereto be, and the same hereby is, approved, ratified, adopted and confirmed and the area and scope of the proposed plan consisting of the following, to-wit: water and sewer facilities as well as water sources in and about said towns including all correlative matters relating thereto be, and the same hereby is approved and confirmed, and the officers of this Board necessary to assist in applying for a planning grant from the Farmers Home Administration by, and they hereby are, duly authorized and constituted to do so."
