Connor, Carbon County Superintendent of Schools, shall be and she is hereby authorized and directed to make application for, in good and sufficient form as is determined by the said Superintendent, a grant from the U. IT IS FURTHER RESOLVED that the said Donna J. Connor, Carbon County Superintendent of Schools, shall be and she is hereby authorized to receive any grant allowed by the U. S. Department of Health, Education and Welfare by reason of the said application, and receive the funds disbursed by the said Department incidental to said grant.
