HEALTH NURSE: The Board confirmed the appointment by the County Health Nurse of Lois Brandjord of Saratoga, Wyo. to serve on a part time basis as Deputy County Health Nurse. Miss Sandra Rafter, Health Nurse, Helen Freeburg of Saratoga, Wyo. and Rhoda Mathiesen of Rawlins, Wyo. discussed the appointment of a Deputy Health Nurse and the Commissioners concurred.

Thereupon the Board adjourned until the following day.

COUNTY FAIR BOARD: The Board reappointed Sam D. Morgan of Dixon, Wyo. as a member of the Carbon County Fair Board for a term commencing February 2, 1966 and expiring February 2, 1971.

LIQUOR DEALERS: The Board of Commissioners will meet with the Carbon County Liquor Dealers on April 6, 1966 at 10:00 A. M. to select four Sunday opening dates for 1966 in Compliance with Wyoming Statutes.

UNION PACIFIC LEASE NO. C.D..45706-C: A motion was made and unanimously carried whereby the following resolution was adopted:

RESOLUTION

WHEREAS, UNION PACIFIC RAILROAD COMPANY has tendered to the COUNTY OF CARBON, STATE OF WYOMING, an agreement extending to and including March 9, 1968, the term of contract dated March 10, 1961, covering lease of premises in Carbon County, Wyoming, for the installation and operation of gravel loading facilities and for the excavation and removal of gravel; said agreement being identified as Union Pacific Railroad Company's C. D. No. 45706-C; and

WHEREAS, the Board of County Commissioners of County of Carbon, State of Wyoming, has said proposed agreement before it and has given it careful review and consideration; and

WHEREAS, it is considered that the best interests of said County of Carbon, State of Wyoming, will be suberved by the acceptance of said agreement;

THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF THE COUNTY OF CARBON, STATE OF WYOMING;

That the terms of the agreement submitted by Union Pacific Railroad Company as aforesaid be and the same hereby are accepted in behalf of the County of Carbon, State of Wyoming;

That the Chairman of the Board of County Commissioners of said County hereby is authorized, empowered and directed to execute said agreement on behalf of said County, and that the County Clerk hereby is authorized, and directed to attest said agreement and to attach to each duplicate original of said agreement a certified copy of this resolution.




