LIQUOR LICENSE: On October 4, 1967 the Commissioners postponed the renewal of the liquor license to the Valley Station, McFadden, Wyoming, Nellie M. Holliday and Betty J. Franzen, pending the sale of the license to Gay Johnson's Wyoming Automotive Service Co., 2½ miles West of Rawlins. At the December 5th meeting of the Board, retail liquor license No. 135 was transferred to Gay Johnson's Wyoming Automotive Service Co. upon payment of an additional fee of Twelve Hundred Dollars (\$1200.00), making a total of Fifteen Hundred Dollars (\$1500.00) paid to Carbon County. A new license, #136, was issued effective October 6, 1967 expiring October 6, 1968. The application was properly advertised in the Rawlins Daily Times on October 28th, November 4th, 11th and 18th.

Thereupon the Board adjourned until the following day.

December 6, 1967 The Board resumed its session, all members present.

SHIRLEY RIDGE ROAD: A motion was made by Orton, seconded by Salisbury and carried whereby the following resolution was adopted.

R E S O L U T I O N

WHEREAS, the Board of County Commissioners of Carbon County, Wyoming has authorized the construction of a highway to Shirley Basin Community, commonly known as the Shirley Ridge Road, and

WHEREAS, such highway meets the requirements of the program and procedure of Public Land Highway Funds under Memo. 24-1 issued January 14, 1961, and

WHEREAS, the Board of County Commissioners feels that the construction of this highway is of vital importance to the economy and industrial development of Carbon County and the State of Wyoming and the safety and welfare of the residents of the camp and the children who are bussed daily to school at Medicine Bow, therefore

BE IT RESOLVED, that a request be made to the Wyoming Highway Department to make an application for funds from the Public Land Highway Funds Authority for the completion of said road, and

BE IT FURTHER RESOLVED, that a copy of this resolution be sent to the Wyoming State Highway Department, The Honorable Gale W. McGee and the Honorable Clifford P. Hansen, U. S. Senators from Wyoming, the Honorable William Henry Harrison, Congressman from Wyoming, Washington, D. C., the Honorable Stanley K. Hathaway, Governor of Wyoming, the Honorable Harry Roberts, Superintendent of Public Instruction, State of Wyoming and the Honorable Roy C. Peck, Director, Natural Resource Board, State of Wyoming.

ADOPTED this 6th day of December, 1967 in regular session of the Board of County Commissioners of Carbon County, Wyoming at Rawlins, Wyoming.
