## COMMISSIONERS PROCEEDINGS

## SPECIAL MEETING

The Board met at 1:30 P.M., all members present, John Orton, Chairman together with members of the Bureau of Land Management of District No. 3 which comprises Carbon, Albany, Fremont and Sweetwater Counties. Also present were members of the Carbon County Woolgrowers and Stock Growers and individuals who are interested in producing a larger tax base for County Government.

A motion was made, seconded and carried whereby the following resolution was adopted, to wit:

R E S O L U T I O N

WHEREAS, the respective counties in Grazing District #3, headquarters Rawlins, Wyoming are in desperate need of additional tax revenue, we the undersigned Commissioners, respectfully request that the transfer of federal lands to private ownership and development be encouraged as much as possible.

Our primary purpose is to produce a larger tax base for County Government.

CLAIM AGAINST CARBON COUNTY - WILLIAM AND NAOMI CHAVEZ: At the november 2, 1966 meeting of the Commissioners they refused to admit liability in claim for damages to house owned by Mr. and Mrs. Chavez which was flooded by the Rawlins Springs. Another claim in the amount of \$3000.00 was submitted by Attorney R. S. Lowe on December 6, 1966. This claim was also rejected.

There being no further business the meeting was adjourned.
