TRANSFER OF FUNDS FROM CASH RESERVE:

In compliance with Section 20-811 of the Municipal Budget Act. W.C.S. 1945, as amended in the Session Laws of 1947. A Notice of Hearing on the proposed transfer of funds from the Cash Reserve Fund was advertised Nov. 23, 1968, as follows: Elections \$2,500.00.

A motion was made by Orton and carried whereby the following resolution was adopted, to-wit:

RESOLUTION

WHEREAS, the above budget has become depleted due to unanticipated costs.

IT IS HEREBY RESOLVED that the County Budget Officer and County Treasurer be authorized to transfer the above mentioned funds.

LIMITED LIQUOR LICENSE: There being no protests entered, the Board of Commissioners granted limited liquor license #144 to Valley Rod and Gun of McFadden, Wyoming, effective 12-4-68, expiring 12-4-69 100.00

It was regularly moved by Commissioner John Orton and seconded by Commissioner John Niland that the following Resolution be adopted:

RESOLUTION

Whereas, there was granted and conveyed to Carbon County, Wyoming, a right of way for road purposed by Quitclaim Deed dated May 15, 1925, and recorded in Book 177 at Page 251 in the office of the County Clerk and Ex-Officio Register of Deeds, Carbon County, Wyoming, for the old Rawlins-Parco Highway, and

Whereas, the public interest no longer requires the use of said road and right of way which has been replaced by U.S. Interstate Highway No. 80; and

Whereas, said right of way should be released and quitclaimed to the adjacent land owner.

NOW, THEREFORE, BE IT RESOLVED that the Chairman of the Board of County Commissioners, John Niland, and the County Clerk, R. G. Engstrom, be, and they are hereby authorized, empowered and directed to execute and deliver a Quitclaim Deed to said right of way as legally described in said instrument dated May 15, 1925, and appearing of record in Book 177 at Page 251 in the office of the County Clerk and Ex-Officio Register of Deeds, Carbon County, Wyoming.

CARBON COUNTY PLANNING AND ZONING COMMISSION: A motion was made by Salisbury and carried whereby the following Resolution was adopted:

RESOLUTION

WHEREAS, in order to promote the public health, safety, morals and general welfare of Carbon County, Wyoming, and inhabitants thereof, the Carbon County Planning and Zoning Commission should be created and established pursuant to Chapter 85, Session Laws of 1959 and Chapter 202, Session Laws of 1967, and

WHEREAS, the Board of the County Commissioners of the County of Carbon, State of Wyoming, is authorized to regulate and to restrict the location and use of buildings and structures and the use, condition of use or occupancy of land for residence, recreation, agriculture, industry, commerce, public use, and other purposes in the unincorporated area of Carbon County, Wyoming.

NOW, THEREFORE, BE IT RESOLVED that there be, and there is hereby created and established the Carbon County Planning and Zoning Commissioner, which shall be composed of five (5) members as hereinafter set forth for a term of office set opposite each name:

1. Vern Scott, Medicine Bow, one-year term.
2. Merwyn Powell, Saratoga, two-year term.
3. Sid Weber, Baggs, three-year term.
4. Irving A. Rendle, Rawlins, four-year term.
5. Roland Murphy, Rawlins, five-year term.

BE IT FURTHER RESOLVED that the term of office of each of said members shall commence on the 4th day of December of each year and continue thereafter until their successors are duly appointed and qualified.

BE IT FURTHER RESOLVED that said Carbon County Planning and Zoning Commission shall organize within thirty (30) days from the date hereof and shall adopt rules for the transaction of its business and keep a record of its actions and determinations.

PARKS AND RECREATION BOARD OF JEFFREY MEMORIAL CENTER: The Board of Commissioners appointed the following members to the above Board, effective December 4, 1968: C. W. Jeffrey, M. D., one-year term; Mrs. H. T. Neuman, two-year term; Mr. Richard Seith, three-year term; Mrs. Charles Stratton, four-year term; and Mr. Oscar A. Hall, five-year term.

SAVAGE RANCH ROAD: It was moved by Commissioner Niland and seconded by Commissioner Salisbury that the following Resolution be adopted:

RESOLUTION

WHEREAS, the public interest requires the establishment of a county highway along the route commonly known as the present Savage Ranch Road, and

WHEREAS, said Savage Ranch Road should be incorporated into the county road system of Carbon County, Wyoming, as a county highway pursuant to Chapter 3, Title 24, Wyoming Statutes, 1957, Compiled 1967.

NOW, THEREFORE, BE IT RESOLVED that the Board of County Commissioners of Carbon County, Wyoming, initiate the procedure for the establishment of the present Savage Ranch Road as a county highway in Carbon County, Wyoming.

BE IT FURTHER RESOLVED that the point of commencement of said county highway is at the intersection of said road with the south right of way line of Interstate 80, said point bearing N. 16°02'E., a distance of 4,193.18 feet from the south one-quarter ( $\frac{1}{4}$ ) corner of Section 35, Township 21 North, Range 85 West, 6th P.M., Carbon County, Wyoming.

thence southerly along the North Platte River thru the east half ( $E\frac{1}{2}$ ) of Section 35; Township 21 North, Range 85 West of the 6th P.M. and thru the east half ( $E\frac{1}{2}$ ) of Section 3, the  $NE\frac{1}{4}$  of Section 10, the  $W\frac{1}{2}$  of Section 11, the  $SE\frac{1}{4}$  of Section 10, the  $E\frac{1}{2}$  of Section 15, the  $NE\frac{1}{4}$  of Section 22, the  $S\frac{1}{2}$  of Section 23 and 24, all in Township 20 North, Range 85 West in the 6th P.M. and thence thru the  $SW\frac{1}{4}$  of Section 19, Township 20 North, Range 84 West and terminating at a point in the  $N\frac{1}{2}NW\frac{1}{4}$  of Section 30, Township 20 North, Range 84 West of the 6th P.M., said road being 6.770 miles in length, more or less.

BE IT FURTHER RESOLVED that the County and Prosecuting Attorney be, and he is hereby authorized to acquire by donation, for and in behalf of Carbon County, Wyoming, from the owners of the lands involved, rights of way for said county highway.

BE IT FURTHER RESOLVED that upon acquisition of such rights of way for county highway purposes, said road shall be deemed to be established by consent pursuant to further Order of the Board of County Commissioners of Carbon County, Wyoming.
