


January 3, 1968      The Board resumed its session, Salisbury and Orton present, Niland absent. Salisbury acted as chairman pro-tem.

COUNTY AGENT: The Board received a letter of resignation effective April 30, 1968 from Dick G. Hiser, County Agent. Mr. Hiser also resigned as a member of the Jeffery Center Board effective March 1, 1968. No appointment was made at this time.

STATE EXAMINERS REPORT: The report of examination of Carbon County Offices from Sept. 1, 1966 to August 23, 1967 was received by the Board. The Board examined the report and will comply with the recommendations of the State Examiners.

COUNTY WELFARE BOARD: Albert B. Schultz, Superintendent of Schools, Rawlins, Wyo. was re-appointed as a member of the Carbon County Welfare Board effective January 1, 1968 the term expiring January 1, 1971.

UNION PACIFIC RAILROAD COMPANY - RIGHT OF WAY LEASE. A motion was made by Niland, seconded by Salisbury and carried whereby the following resolution was adopted.

WHEREAS, UNION PACIFIC RAILROAD COMPANY has tendered to COUNTY OF CARBON, STATE OF WYOMING, an agreement extending to and including February 28, 1969, the term of contract dated August 9, 1934, granting to the County certain rights for highway purposes in portions of the Railroad Company's right of way in Carbon County, Wyoming; said agreement being identified as Union Pacific Railroad Company's Audit No. A-42757, C. D. No. 9221-J and 9221-C; and

WHEREAS, the Board of County Commissioners of the County of Carbon has said proposed agreement before it and has given it careful review and consideration; and

WHEREAS, it is considered that the best interests of said County of Carbon, State of Wyoming, will be subserved by the acceptance of said agreement;

THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF CARBON COUNTY, STATE OF WYOMING:

That the terms of the agreement submitted by Union Pacific Railroad Company as afore-said be and the same hereby are accepted in behalf of Carbon County, State of Wyoming:

That the Chairman of the Board of County Commissioners of said County hereby is authorized, empowered and directed to execute said agreement on behalf of said County, and that the County Clerk hereby is authorized and directed to attest said agreement and to attach to each duplicate original of said agreement a certified copy of this resolution.
