

POLL TAX: The Board authorized the County Assessor to proceed with the collection of Poll Tax for the year 1968.


BOND: The Board approved the Bond of Lula Ayer as treasurer of Baggs cemetary district in the amount of \$1000.00.

TAX ABATEMENT: Paul L. Plattner, Pine Ridge, Ark. erroneous assessment \$13.46.


TAX REBATE ORDER #1677 - Clinton R. Cattles, Rawlins double payment of poll tax \$2.00.
