A regular meeting of the Board of County Commissioners (herein "Board") of the County of Carbon, State of Wyoming, was held at the regular meeting place of the Board in the Commissioners' Room in the Carbon County Courthouse in Rawlins, Wyoming, in said County, on Tuesday, the 7th day of May, 1968, at the hour of 10:00 o'clock a.m., pursuant to notice and call duly given to each member of the Board.

The meeting was called to order by the Chairman of the Board, and upon roll call the following members were found to be present, constituting a quorum:

constituting all the members of the Board.

The following proceedings, among others, were had and taken:

Thereupon, Commissioner John Orton introduced the following resolution, which was thereupon read in full and is as follows:

R E S O L U T I O N

Page 46

WHEREAS, the County of Carbon (herein "County"), in the State of Wyoming, is a county duly organized and existing as such under the Constitution and laws of the State of Wyoming; and

WHEREAS, the Board of County Commissioners of the County (herein "Board"), has determined, and does hereby determine, that it is necessary and for the best interests of the County and its inhabitants that a new county hospital be constructed and equipped; and

WHEREAS, there are not sufficient funds in the treasury of the County available for that purpose; and

WHEREAS, at a bond election of the qualified electors of the County held therein on the 5th day of December, 1967, the Board was authorized to issue the registered coupon bonds of said County, in an amount not to exceed \$1,000,000.00, or so much thereof as may be necessary, for the purpose of providing means for the construction and equipment of a new county hospital, said bonds to bear interest at a rate or rates not to exceed six per centum (6%) per annum, and to be issued and sold upon such lawful terms and conditions, and with such covenants and agreements as the Board may determine, including, at its option, provisions for the redemption of bonds prior to maturity without or with the payment of a premium ;and

WHEREAS, pursuant to the statutes of the State of Wyoming, notice of the sale of said bonds was duly given by publication of a notice of sale in the Rawlins Daily Times, a newspaper of general circulation published in the County and in the Wyoming State Tribune, a newspaper of general circulation published in Cheyenne, Wyoming; and

WHEREAS, pursuant to said notice of sale, sealed bids were received and publicly opened for the purchase of said bonds on the 26th day of March, 1968; and

WHEREAS, the bid submitted by The Northern Trust Company, Chicago, Illinois, and associates (hereinafter "Purchasers"), for the purchase of said bonds, bearing

interest as hereinafter set forth, at par and accrued interest to the date of delivery and a premium of \$69.00, was the best bid submitted and was informally accepted by the Board; and

WHEREAS, the Board has determined, and does hereby determine, that it is necessary and for the best interests of the County and the inhabitants thereof to provide for the authorization and issuance of said bonds in the aggregate principal amount of \$1,000,000.00.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS OF THE COUNTY OF CARBON, STATE OF WYOMING:

Section 1. Ratification. That all action heretofore taken (not inconsistent with the provisions of this resolution) by the Board and the officers of the County directed toward providing means for the construction and equipment of a new county hospital, and toward the issuance of "Carbon County, Wyoming, General Obligation Hospital Building Bonds, Series May 1, 1968, " in the aggregate principal amount of \$1,000,000.00, for that purpose be, and the same hereby is, ratified, approved and confirmed, including, without limiting the generality of the foregoing, the action of the Board in accepting the proposal submitted by the Purchaser for the purchase of the bonds.

Section 2. Bond Details. That for the purpose of protecting the public health and advancing the general welfare of the citizens of the County, and for the purpose of providing means for the construction and equipment of a new county hospital, the County of Carbon, in the State of Wyoming, on behalf of said County and upon the credit thereof, shall issue its negotiable, coupon, general obligation bonds designated "Carbon County, Wyoming, General Obligation Hospital Building Bonds, Series May 1, 1968," in the aggregate principal amount of \$1,000,000.00, dated May 1, 1968, payable to bearer, consisting of 1000 bonds in the denomination of \$1,000.00 each, numbered consecutively in regular numerical order from 1 to 1000, both inclusive, and bearing interest from the date thereof until their respective maturities

at the respective rates hereinafter set forth, as evidenced by one set of interest coupons attached to said bonds, said interest being payable on the first day of May, 1969, and semiannually thereafter on the first days of May and November in each year, and being numbered and maturing serially, on the first day of May, in the designated amounts and years, as follows:

both principal of said bonds and the interest thereon being payable in lawful money of the United States of America, without deduction for exchange or collection charges, at the office of the County Treasurer of Carbon County, in Rawlins, Wyoming. If any bond shall not be paid upon presentation at maturity, it shall continue to draw interest at the rate of six per centum (6%) per annum until the principal thereof is paid in full.

Section 3. Prior Redemption Option. That bonds numbered 1 through 500, maturing on and before the first day of May, 1978, shall not be subject to prior redemption. Bonds numbered 501 through 1000, maturing on and after the first day of May, 1979, shall be subject to redemption prior to their respective maturities, in inverse numerical order, at the option of the County, on the first day of May, 1978, or on any interest payment date thereafter, at a price equal to the principal amount of each bond so redeemed, accrued interest thereon to the redemption date and a premium computed in accordance with the following schedule:

2% of the principal amount of each bond redeemed, if redeemed on or after May 1, 1978, and on or before November 1, 1983; and

1% of the principal amount of each bond redeemed, if redeemed thereafter.

Section 4. Notice of Prior Redemption. That notice of any prior redemption shall be given by the County Treasurer in the name of the County, upon being authorized and directed so to proceed by resolution or motion duly adopted by the Board:

A. By publication of such notice at least once, not less than thirty days prior to the redemption date, in a newspaper of general circulation in the County; and

B. By sending a copy of such notice by registered, first-class, postage prepaid mail at least thirty days prior to the redemption date to the The Northern Trust Company, Chicago, Illinois.

Such notice shall specify the number or numbers of the bonds to be so redeemed (if less than all are to be redeemed) and the date fixed for redemption; and such notice shall further state that on such redemption date there will become due and payable upon each bond so to be redeemed at the office of the County Treasurer of Carbon County, Wyoming, in Rawlins, Wyoming, the principal amount thereof, accrued interest thereon to the redemption date and the stipulated premium, and that from and after such date interest will cease to accrue.

Notice having been given in the manner hereinbefore provided, the bond or bonds so called for redemption shall become due and payable on the redemption date so designated; and upon presentation thereof at the office of the County Treasurer, together with all appurtenant coupons maturing subsequent to the redemption date, the County Treasurer will pay the bond or bonds so called for redemption. Section 5. Negotiability. That title to any bond or to any coupon shall pass by delivery merely, as a negotiable instrument payable to bearer. Subject to the provisions specifically made or necessarily implied herein, the bonds and the coupons appertaining thereto shall be fully negotiable and shall have all the qualities of negotiable paper, and the holder or holders thereof shall possess all rights enjoyed by the holders of negotiable instruments under the provisions of the Uniform Commercial Code - Investment Securities.

Section 6. Filing Manual Signatures. That prior to the execution of any bond, pursuant to the Uniform Facsimile Signature of Public Officials Act, adopted as Chapter 34, Session Laws of Wyoming, 1959, and also cited as Sections 9-18.1 to 9-18.4, both inclusive, Wyoming Statutes 1957, 1967 Cumulative Supplement, the Chairman of the Board, the County Clerk and the County Treasurer shall each forthwith file with the Secretary of State his or her manual signature certified by him or her under oath.

Section 7. Execution of Bonds and Coupons. That thereafter, each of said bonds shall be manually signed and executed in the name of the County by the Chairman of the Board of County Commissioners, and shall be signed, executed and attested with the engraved, imprinted, stamped or otherwise reproduced facsimile of the signature of the County Clerk. A printed, engraved, stamped or otherwise reproduced facsimile of the seal of the County shall be affixed thereto. The Clerk of the County shall endorse with his facsimile signature and a facsimile seal a certificate upon every bond that the same is within the lawful debt limit of the County and that the same is issued according to law. Each bond so issued shall be registered by the County Treasurer in a book to be kept for that purpose, and therein shall be stated the number, date of issue, to whom issued, amount of the bonds, date of redemption, and payment of interest and principal, and the County Treasurer shall execute, with a facsimile signature, a registration certificate to that effect. Said bonds shall also be registered by the County Clerk as required by law. Each bond shall have attached thereto an appropriate number of interest coupons to be signed - Page 51 with the facsimile signature of the County Treasurer covering the interest expressed in the bond from the date of issue until paid, at a rate not to exceed the rate specified in such bond.

Section 8. Effect of Signatures. That the bonds, coupons, and certificates bearing the signatures of the officers in office at the time of the signing thereof, shall be the valid and binding obligations of the County, notwithstanding that before the delivery thereof and payment therefor, any or all of the persons whose signatures appear thereon shall have ceased to fill their respective offices. Each of said officers, at the time of the execution of a signature certificate appertaining to the bonds by said officer, and in the case of the Chairman also at the time of the execution of the bonds, may adopt as and for his own facsimile signature the facsimile signature of his predecessor in office in the event that such facsimile signature appears upon any of the bonds, coupons or certificates appertaining to the bonds.

Section 9. Form of Bonds, Coupons and Certificates. That said bonds, the coupons thereto attached, and the certificates to appear thereon shall be in substantially the following form, to-wit:

If upon presentation at maturity, payment of this bond is not made as herein provided, interest hereon shall

continue at the rate of six per centum (6%) per annum until the principal hereof is paid in full.

The bonds of the series of which this is one maturing on and before the first day of May, 1978, are not subject to prior redemption. The bonds of said series maturing on and after the first day of May, 1979, are subject to redemption prior to their respective maturities in inverse numerical order, at the option of the County, on the first day of May, 1978, or on any interest payment date thereafter prior to maturity, for the principal amount of each bond so redeemed, accrued interest thereon to the redemption date, and a premium computed in accordance with the following schedule:

2% of the principal amount of each bond redeemed, if redeemed on or after May 1, 1978, and on or before November 1, 1983; and

1% of the principal amount of each bond redeemed, if redeemed thereafter.

Redemption shall be made upon not less than thirty days' prior published and mailed notice in the manner and upon the conditions provided in the resolution authorizing the issuance of the bonds of said series.

This bond is one of a series of bonds of like tenor, amount and date, except as to number and maturity, issued by the County of Carbon, in the State of Wyoming, upon its behalf and upon the credit thereof, for the purpose of providing means for the construction and equipment of a new county hospital, in full conformity with the Constitution and statutes of the State of Wyoming, and in particular, the provisions of Chapter 9 and Article 3, Chapter 5, Title 18, Wyoming Statutes 1957, and all laws amendatory thereof and supplemental thereto, and by virtue of the authority of the vote of the majority of the qualified electors of said County voting upon said question at a special bond election held in said County on the 5th day of December, 1967.

It is hereby recited, certified and warranted that all of the laws of the State of Wyoming have been fully complied with by the proper officers of the County in the issuance of this bond; that all acts and things required to be done, and conditions and things required to exist precedent to and in the issue of this bond to render the same lawful and valid, have happened, been properly done and performed, and did exist in regular and in due time, form and manner, as required by law; that the total indebtedness of the County, including that of this bond, does not exceed any limit of indebtedness prescribed by the Constitution or laws of the State of Wyoming; and that provision has been made for the levy and collection of annual taxes sufficient to pay the interest on and the principal of this bond when the same become due.

The full faith and credit of the County of Carbon, in the State of Wyoming, are hereby pledged for the punctual payment of the principal of and interest on this bond.

IN WITNESS WHEREOF, the Board of County Commissioners of the County has caused this bond to be signed and executed in the name of and on behalf of the County by the Chairman of its Board of County Commissioners, and to be signed, executed and attested with the facsimile signature of the County Clerk, has caused the facsimile of the seal of the County to be affixed hereon, and has caused the interest coupons appertaining hereto to be signed with the facsimile signature of the County Treasurer, all as of the first day of May, 1968.

Section 10. Delivery. That said bonds, when executed and registered as provided by law, shall be, by the County Treasurer, delivered to the Purchasers upon the payment by said Purchasers to said County Treasurer of the agreed purchase price, and the proceeds derived therefrom shall be used exclusively for the purpose recited in said bonds as hereinbefore set forth, but the Purchasers or any holder from time to time shall in nowise be responsible for the application of the proceeds of said bonds by said Board or the County or any officers thereof.

Section 11. Payment of Bonds and Interest. That the principal and interest falling due on said bonds on the first day of May, 1969, shall be paid out of any funds of said County available for such purpose, and for the purpose of reimbursing such fund or funds, meeting the interest accruing on said bonds thereafter promptly and as the same becomes due, and paying the principal of said bonds as it matures serially; there shall be levied by the Board, on all the taxable property in said County, in addition to all other taxes, direct annual taxes sufficient for said purpose, and said taxes shall be collected in the same manner as other taxes for County purposes. Said taxes, when collected, except for the said reimbursement of such fund or funds, shall be applied solely for the payment of said interest on and principal of said bonds, respectively, and for no other purpose whatever, until the indebtedness so contracted under this resolution, both principal and interest, shall have been fully paid, satisfied and discharged; but nothing herein contained shall be so construed as to prevent said County from applying any other funds that may be in the Treasury of the County and available for that purpose, to the payment of interest or principal, as the same respectively mature, and the levy or levies herein provided for may thereupon to that extent be diminished.

Section 12. Supplemental Powers. That the officers of said County be, and they hereby are, authorized and directed to take all action necessary or appropriate to effectuate the provisions of this resolution, including, without limiting the generality of the foregoing:

(a) Printing Bonds. The printing of said bonds, including thereon a certified true copy of bond counsel's approving opinion; and

(b) Final Certificates. The execution of such certificates as may properly be required by the Purchasers relating to the signing of the bonds, the tenure and identity of the County Officials, the assessed valuation and indebtedness of said County, the delivery of the bonds and the receipt of the bond purchase price, and, if in accordance with the facts, the absence of litigation, pending or threatened, affecting the validity thereof.

Section 13. Repealer. That all acts, orders or resolutions or parts thereof in conflict with this resolution be and the same hereby are repealed.

Section 14. Resolution Irrepealable. After the bonds hereby authorized have been issued, this resolution shall constitute a contract between the County and the holder or holders of said bonds, and shall be and remain irrepealable until said bonds and the interest accruing thereon shall have been fully paid, satisfied and discharged.




Section 15. Severability. Section 16. Emergency. That by reason of the fact that said County is not properly or adequately supplied with hospital facilities, it is hereby declared that an emergency exists, that this resolution is necessary to the immediate preservation of the public peace, health and safety, and that it shall be in full force and effect immediately after its adoption and approval.

Section 17. Recordation. That this resolution and order shall be entered of record in the minute book of the Board of County Commissioners, and the County Clerk is authorized and directed to carry out the provisions hereof.




