RESOLUTION

WHEREAS, the Board of County Commissioners of Carbon County, Wyoming, by Resolution duly adopted pursuant to Section 24-43, Wyoming Statutes, 1957, did deem that the public interest required the vacation of a certain county highway, hereinafter described, and

WHEREAS, R. A. Hakala, a suitable and disinterested elector of Carbon County, Wyoming has been appointed viewer pursuant to Section 24-45, Wyoming Statutes, 1957, to examine into the expediency of the proposed vacation of said public road, and.

WHEREAS, said viewer has reported in writing this date that in his judgement the vacation of old Wyoming Highway Department Highway No. 130-230 in Section 5, 8, 9 and 16, Township 16 North, Range 83 West of the Sixth Principal Meridian, Carbon County, Wyoming, is practicable and said road should be vacated; and

WHEREAS, said viewer further reports that in his judgment no damages to the property owners along the line of said road to be vacated will accrue but will be beneficial to said property owners and that the probable expense of vacation is Fifty Dollars (\$50.00); and

WHEREAS, notice of abandonment and vacation of public road has heretofore been published in The Rawlins Daily Times as by law required; and

WHEREAS, a copy of said notice has heretofore been mailed to all persons owning lands or claiming any interest in any lands over or across which said public road is to be vacated; and

WHEREAS, no objections to the vacation of said road and no claims for damages by reason thereof having been filed with the County Clerk of Carbon County, Wyoming; and

WHEREAS, the Board of County Commissioners does hereby determine that the vacation of said road is in the public interest.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS duly convened at a regular meeting this day that a certain portion of the old Wyoming Highway Department Highway No. 130-230, described as follows:

All that portion of Section 16, T. 16 N., R. 83 W., 6th P.M., Carbon County, Wyoming, lying between parallel right-of-way lines 80 feet apart, being 40 feet on each side of the following described centerline of road:

Beginning at a point which bears S. $76^{\circ}19'$ W., a distance of 2511.06^{\pm} feet from the W. 1/4 corner of said Section 16, said Township & Range, said point being the intersection of said centerline of road, and the centerline of a right-of-way accommodating the existing Wyoming Highway Department Highway No. S-0103 (2) and Wyo. 130 at station $31 + 87.10$;

thence, S. $26^{\circ}10'$ E., a distance of 2086.8^{\pm} feet to the point of beginning of a $15^{\circ}00'$ curve to the right; through a central angle of $52^{\circ}40'$, along a radius of 382 feet, a distance of 351.1 feet to the point of ending of said curve;

thence, S. $26^{\circ}30'$ W., a distance of 375.6^{\pm} feet to a point of intersection with the South section line of said Section 16, said Township and Range.

The above described right-of-way is 0.533 miles in length, and contains approximately 5.167 acres.

All that portion of Sections 5, 8, 9 and 16, T. 16 N., R. 83 W., 6th P.M., Carbon County, Wyoming, lying between parallel right-of-way lines 80 feet apart being 40 feet on each side when measured at right angles of radially to the following described centerline of road;

Beginning at a point which is an intersection of the heretofore mentioned centerline of road, and the centerline of a recently constructed highway (Wyo. 130-230 Wyo. Project No. F-022-1 (4)) said point bears N. $7^{\circ}55'$ W., a distance of 4004.16^{\pm} feet from the South 1/4 corner of Section 5, said Township and Range;

thence, S. $42^{\circ}38'$ E., a distance of 752.19^{\pm} to the point of beginning of a $2^{\circ}00'$ circular curve to the right;

thence, along a radius of 2864.8 feet through a central angle of $16^{\circ}28'$, a distance of 823.3 feet to the point of ending of said curve;

thence, S. $26^{\circ}10'$ E., a distance of $10,958.30^{\pm}$ feet the point of termination of said centerline of road, said point being an intersection of said centerline of road, and the centerline of an existing recently constructed highway (Wyo. Highway 130-Wyo. Project No. S-0103 (2)) said point bears N. $76^{\circ}19'$ E., a distance of 2511.06^{\pm} feet from the West 1/4 corner of Section 16, said Township and Range.

Said portion of land contains approximately 23.019 acres, and is approximately 2.374 miles in length,

be, and the same is hereby vacated and abandoned pursuant to the statute in such case made and provided.

BE IT FURTHER RESOLVED that a certified copy of this Resolution be made a matter of public record and recorded in the official records in the office of the County Clerk and Ex- Officio Register of Deeds, Carbon County, Wyoming.
