A motion was made by Commissioner Salisbury, seconded by Orton and unanimously carried whereby B. G. Michie was appointed to the position of County Treasurer effective June 4, 1969, his term expiring January 4, 1971.

COUNTY SUPERINTENDENT OF SCHOOLS: The Board received a letter of resignation from Donna J. Connor, County Superintendent of Schools effective August 23, 1969. The resignation was accepted and no appointment was made. Mrs. Christel J. Humphreys, Deputy Superintendent of Schools will maintain the office until the statutory closing of this office effective January 4, 1971.
