THE FOLLOWING resolution was adopted by the Board:

R E S O L U T I O N

A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF CARBON COUNTY, STATE OF WYOMING, APPROVING THE SECOND ADDITION TO THE TOWN OF MEDICINE BOW, WYOMING.

WHEREAS, the Mayor and Governing Body of the Town of Medicine Bow, Carbon County, Wyoming, at a regular meeting held on the 3rd day of November, 1969, accepted and confirmed the dedication to the public of the streets and alleys designated and laid out on the map and plat of the Second Addition to the Town of Medicine Bow, Wyoming;

NOW, THEREFORE, the Board of County Commissioners of Carbon County hereby approve of the plat of Second Addition to the Town of Medicine Bow, Wyoming, which addition is platted over the following described lands:

A parcel or tract of land situated in the SE $\frac{1}{4}$  of the SW $\frac{1}{4}$  and the SW $\frac{1}{4}$  of the SE $\frac{1}{4}$  of Section 5, Township 22 North, Range 78 West of the Sixth Principal Meridian, in Carbon County, Wyoming, bounded and described as follows:

Beginning at a point on the south line of said Section 5 that is 60.0 feet distant east, measured at right angles, from the northerly extension of the east line of Block 21 of the Union Pacific Railroad Company First Addition to the Town of Medicine Bow, Carbon County, Wyoming;

Thence north along a straight line parallel with and 60.0 feet distant east, measured at right angles from said extension of the east line of Block 21 a distance of 410.0 feet;

Thence west along a straight line parallel with the south line of said Section 5 a distance of 990.0 feet to a point in the northerly extension of the west line of Block 19 of said Union Pacific Railroad Company's First Addition;

Thence north along said extension of the west line of Block 19 a distance of 300.00 feet;

Thence east along a straight line parallel with said south line of Section 5 a distance of 1,116.0 feet;

Thence south along a straight line parallel with and 186.0 feet distance east, measured at right angles, from said northerly extension of the east line of Block 21 a distance of 710.0 feet to a point on said south line of Section 5;

Thence west along the south line of Section 5 a distance of 126.0 feet to the point of beginning;

Containing an area of 8.87 acres, more or less.

BE IT FURTHER RESOLVED that the Chairman of this Board be, and he is hereby, authorized, directed and empowered to endorse upon the official plat of Second Addition to the Town of Medicine Bow, Wyoming, the approval of this Board and that his signature be attested by the County Clerk under the official seal of Carbon County.
