A Motion was made and carried whereby John Niland was elected temporary chairman of the new Board.

A motion was then made by Orton, seconded by Salisbury and carried, that John Niland be elected permanent chairman of the Board of Commissioners for a two year term, expiring January 4, 1971

ORDER

An order was entered into by the Board of Commissioners that the above named road be established as described in the Notice of Location of Public Road in Commissioners record No. 12 Page 49, Dec. 4, 1968. A metes and bounds description is on file in the office of the County Clerk, in the official order of the Board.

WELFARE BOARD: George R. Salisbury Jr. was re-appointed as a member of the County Welfare Board, his term to expire January 4, 1971.

COUNTY DEPOSITORIES, as follows were designated by the Board.

Rawlins National Bank, Rawlins, First National Bank, Rawlins, Saratoga State Bank, Saratoga and Rawlins Federal Savings and Loan Rawlins.

OFFICIAL NEWSPAPER, Rawlins Daily Times, was designated as the official County newspaper for the next 2 year term ending January 4, 1971.

QUIT CLAIM DEED: It was moved by Commissioner Orton, and seconded by Commissioner Niland and unanimously carried that the Chairman of the Board and County Clerk execute and deliver a corrective Quitclaim Deed in order to include an omission of real property in that Deed dated July 9, 1936 and recorded July 21, 1936 as Instrument No. 147781 in Book 221 at Page 633 in the office of the County Clerk and Ex-Officio Register of Deeds, Carbon County, Wyoming, wherein Carbon County, Wyoming was Grantor and George L. Blair, now deceased, was Grantee. Thereupon the Board adjourned until the following day.

January 8, 1969 The Board resumed its session all member present, Niland Chairman.

COUNTY FAIR BOARD: Phillip Espy appeared before the Board and submitted his resignation as a member of the County Fair Board, which was accepted. Ray L. Lefforge was appointed to fill the unexpired term of Phillip Espy on the Fair Board, his term expires February 2, 1970.

KENNETH DAY ROAD- ABANDONMENT: Winthrop C. Condict and Elsie E. Condict, husband and wife, and Ruth Baldwin having filed a protest to the proposed abandonment of public road in Section 16, Township 16 North, Range 83 West of the 6th P. M., said Notice of Abandonment having been published in the Rawlins Daily Times on November 16, 23, 30, 1968, it was moved by Commissioner Orton, and seconded by Commissioner Salisbury and regularly carried that further proceedings relative to the matter be tabled.

There being no further business the meeting was adjourned.
