The Board met at 2:00 P.M. in special session, Niland Chairman and Orton present, Salisbury absent.

## SHIRLEY BASIN TOWNSITE ACCESS ROAD:

TO ALL TO WHOM IT MAY CONCERN: The Board of County Commissioners have decided to locate a road commencing at a point on east right of way line of State Highway which lies N.00°11'20" E. 1205' and S. 89°17'37" W. 2710.50' from the west  $\frac{1}{4}$  corner Sec. 20, Township 27 N., Range 78W which is designated Station 0+00, thence N. 89°17'37" E. 2665.50' to a point, thence on a 3° curve to right, a distance of 466.70'; thence S.76° 42'23" E. 3043.80' to a point on the west boundary of Shirley Basin Townsite, which point lies North 485' from the westernmost Southwest corner of said townsite, and which point is designated as Station 58+20, terminating at Shirley Basin Townsite. Road right of way to be 100' on each side of centerline.

All objections thereto or claims for damages by reason thereof must be filed in writing with the County Clerk of said County before noon on the 8th Day of July 1970 or such road will be established without reference to such objections or claims for damages. Map is on file in office of County Clerk.
