COUNTY CORONER: A letter of resignation was received and accepted by the Board from County Coroner, Patrick B. Kavaney M. D. effective June 14, 1970. Dr. Kavaney is leaving Rawlins for further study in his profession.

COMMUNITY ACTION AGENCY: Mrs. Paul Hilliard of Saratoga, Wyo. was appointed to this agency.

ELECTION DISTRICTS AND POLLING PRECINCTS

In compliance with Article 4, sections 22-118-65 and 22-118-66, the Board of Commissioners established the voting districts and precincts as follows; several districts and precincts were consolidated as voting machines will be used in Rawlins, Medicine Bow, Hanna, Elk Mountain, Saratoga, Encampment, Snake River and Sinclair. The Board reduced the number of voting precincts from 32 to 21. The use of machines also eliminates the use of counting boards. The usual paper ballots will be used in all precincts that do not have voting machines, also paper ballots will be used for absentee voting.

DISTRICT 1 - RAWLINS

All that area encompasses by the following closed perimeter description shall be known as ELECTION DISTRICT No. 1:

Beginning at a point which is the intersection of the UPRR and tenth street; thence Northerly along 10th Street, including the Chrisman Block, to an intersection with Buffalo Street; thence easterly along Buffalo Street and the projection thereof to an intersection with the projected South line of Sawtell's First Addition; thence east along said Sawtell's Addition south boundary and the projection therof to an intersection of the east city limits; thence south along the east city limits to the south city limits; thence West to the West city limits; thence North along West city limits to an intersection with the UPRR; thence easterly along the UPRR to the original point of begining.

DISTRICT 2 - RAWLINS

Beginning at the NE corner of Sec. 4, Tp. 24 N, R. 87W, running thence west along the Tp. line between Tps. 24 and 25, and to the NW. corner of Tp. 24N., R. 89W; thence south along the west boundary line of Carbon County to the southwest corner of Sec. 35, Tp. 20 N.R. 90W thence west on Tp. line between Tps. 19 and 20 to the range line between ranges 90 and 91; thence south on range line between range 90 and 91 to the southwest corner of Tp. 16N.R. 90W; thence east on the Tp. line between Tp. 15 and 16 to the line between ranges 87 and 88W; thence north on the range line between ranges 87 and 88 to the southwest corner of Tp. 18N., R. 87W; thence east on the Tp. line between Tp. 17 and 18 to the southeast corner of Tp. 18N., R. 86W; thence north on range line between ranges 85 and 86 to the Tp. line between Tps. 18 and 19; thence east on the township line between Tps. 18 and 19 to the range line between ranges 84 and 85; thence north on range line between ranges 84 and 85 to Tp line between Tps. 19 and 20; thence west on township line between Tps. 19 and 20 to the range line between ranges 85 and 86; thence north on range line between ranges 85 and 86 to the northeast corner of Tps 20N R. 86W; thence west on township line between Tps. 20 and 21 to the southeast corner of Tps. 20 and 21 to the southeast corner of Tps. 21N., R. 87W; thence north on range line between ranges 86 and 87 to the Tp. line between Tps. 21 and 22; thence west on the Tps. line between Tps 21 and 22 to the southeast corner of Sec. 33 Tp., 22N. R.87W; thence north to the place of beginning, Ne corner Sec. 4, Tp. 24N. R. 87W.

DISTRICT 3 - RAWLINS

All that area encompassed by the following closed perimeter description shall be known as ELECTION DISTRICT NO. 3:

Beginning at a point which is the intersection of Buffalo Street and Seventh Streets; thence northerly along Seventh Street and the projection thereof to an intersection with the north city limits; thence west along said city limits to an intersection with the west city limits; thence south along said west city limits to an intersection with the U. P. R. R. to an intersection with Tenth Street; thence northerly, excluding the Chrisman Block, to an intersection with Buffalo Street; thence easterly along Buffalo Street to the original point of beginning.

DISTRICT 4 - LAMONT

Beginning at a point on the West line of Carbon County which is the S.W. corner of T. 25N R. 89W.; thence E. along the S. line of T. 25N. to the S. E. Corner of T. 25N.R. 85; thence north along township line between ranges 84 and 85 to the PatheFinder Reservoir following west line of the Pathe Finder Reservoir to north line of Carbon County; thence west to N. W. corner of T. 28 R. 89; thence south along County line or point of beginning

DISTRICT 5 - SEMINOE DAM

Beginning at the S. W. corner of T. 25 R. 84W, thence east to the west bank of the Seminoe Reservoir following the west bank of the Seminoe Reservoir and the North Platte River and the Pathe Finder Reservoir to its intersection of the west line of R 84, thence S. along range line between ranges 84 and 85 to the point of beginning.

All that area encompassed by the following closed perimeter description shall be known as ELECTION DISTRICT NO. 7:

Beginning at a point which is intersection of E. line of Carbon County and the S. line of T. 22N.; thence N. to the N. line of T. 26N.; thence W. to the N. W. corner of T. 26N., R 80W.; thence S. to S. W. corner of T. 26N., R 80W.; thence E. to the S. E. corner of said T. & R.; thence S. to the S. E. corner T. 25N., R 80W.; thence W. to the N. W. corner of T. 24N., R. 80W.; thence S. to the S. W. corner of said T., & R.; thence E. to the S. E. corner of said T. & R.; thence S. to the S. W. corner of T. 22N., R. 79W.; thence E. to the original point of beginning.

DISTRICT NO. 8- HANNA

All that area encompassed by the following closed perimeter description shall be known as ELECTION DISTRICT NO. 8:

Beginning at a point which is the S. E. corner of T. 21 N., R. 81 W.; thence N. to the S. E. of T. 22N., R81W.; thence E. to the S. E. corner of T. 22N., R.80W.; thence N to the N. E. corner of T. 23N., R. 80W.; thence W. to the S. E. corner T.24N., R. 81W.; thence N.to the N. E. corner of said T. & R.; thence W. to the N. W. corner of said T. & R.; thence S. to the S.
