MEDICINE BOW-SHIRLEY BASIN ROAD, Project S-0409(1)  
A motion was made by Salisbury and second by Orton and carried, whereby the following Resolution was adopted; to wit:

RESOLUTION

WHEREAS, The Board of County Commissioners of Carbon County, Wyoming deems the public interest requires that a road be establised to be known as the MEDICINE BOW-SHIRLEY BASIN ROAD, Project S-0409(1) described as follows:

Commencing at a point on the north boundary of Section 25, T 28N., R. 79 W. from which the northwest corner of said Section 25 bears S. 89°18W. a distance of 3274.97 feet; thence easterly for distance of approximately 0.8 miles and southerly for a distance of approximately 13.9 miles through Section 25, T. 28 N., R. 79 W.;

Sections 30 and 31, T. 28 N., R. 78 W.; Sections 6, 7, 18, 19, 30, and 31, T. 27 N., R. 78 W.;

Sections 6 and 7, T. 26 N., R. 78 W.; Sections 12, 13, 24, 25, 26, 36 and 35, R.26 N., R. 79 W.;

to a point of ending in said Section 35 on the northerly right of way boundary of Wyoming State Highway No. 487.

WHEREAS a right of way has been secured from the Sullivan Company and from the State of Wyoming and from the United States Government as owner of the lands crossed by said road, and WHEREAS easements or quit claim deeds or agreements covering mineral interest have been secured from Petrotomics Company, Phillip E. Flanagan, Zweifel International Prospectors, Utah Construction & Minning Company and American Nuclear Corporation,

NOW THEREFORE BE IT RESOLVED that the Medicine Bow-Shirley Basin Road as described above be and it hereby is declared established as a public road.
