A regular meeting of the Board of County Commissioners of the County of Carbon, State of Wyoming, was held at the County Courthouse in Rawlins, Wyoming, on Wednesday, the 2nd. day of December, 1970, at the hour of 10 o'clock A. M.

The Chairman of the Board called the meeting to order and upon roll call the following were present:

Thereupon Commissioners Salisbury introduced the following Resolution, which was read in full and is as follows:

#### R E S O L U T I O N

WHEREAS, the Board of County Commissioners of Carbon County has heretofore determined to construct and equip a County Memorial Hospital in Rawlins, for the County and the inhabitants thereof; and

WHEREAS, the Board has further determined that there are not sufficient funds on hand to complete the construction and equipping of the hospital; and

WHEREAS, the Board has further determined that it is in the best interest of the County to submit to the qualified, registered electors at a special election, the question of issuing general obligation bonds of the County in the principal amount of \$335,000.00, for the purpose of completing the construction and equipping of the County Memorial Hospital;

THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF CARBON COUNTY, WYOMING:

Section 1. That at a special election to be held in Carbon County, Wyoming, on Tuesday, the 29th day of December, 1970, there shall be submitted to the qualified registered electors of the County the question and proposition more particularly described in the Notice and ballot hereinafter set forth.

Section 2. The election on the question of contracting bonded indebtedness of the County shall be conducted, canvassed and returned and the result declared, in the manner prescribed by law for other county elections.

On the day of said election the polls shall be opened at 9:00 o'clock A. M. and they shall be kept open without any adjournment until 7:00 o'clock P. M., at which time the polls shall be closed. The county election districts and precincts and the polling place within each precinct for voting on the question of issuing bonds, shall be as designated by the Board of County Commissioners, as more particularly set forth in the notice of election.

Section 3. At each polling place there shall be provided two ballot boxes, one to be designated Ballot Box "A" and the other Ballot Box "B". there shall also be provided two sets of ballots, one of which shall be printed on white paper and the other on colored paper; both of which shall contain the same statement of the question to be voted upon and the same instructions concerning the manner of marking ballots.

If such elector is not the owner of or the spouse of the owner of real or personal property assessed on the assessment roll of said County, he shall be furnished by the officers conducting said election a ballot printed on white paper and the ballots of all such persons shall be deposited in Ballot Box "A".

If such elector is the owner of or spouse of the owner of real or personal property assessed on the assessment roll of said County, he shall be furnished by such officers a ballot printed on colored paper; and the ballots of all such persons shall be deposited in Ballot Box "B".

Section 4. Every citizen of the United States of the age of 21 years and upwards, who has resided in the State of Wyoming one year, in the County of Carbon sixty days and in the Election precinct wherein he seeks to vote ten days next preceding said election, and who has complied with the registration laws, shall be entitled to vote thereat, provided he appears in person at the polls on election day.

Before any person shall be permitted to vote as a property owner, he or she shall be required to make, before the officers of election, an affidavit showing that he or she is the owner of or the spouse of the owner of real or personal property assessed on the assessment rolls of said County.

Section 5. The official Ballot to be used at said election on the question of issuing bonds shall be in substantially the following form:

QUESTION SUBMITTED:

"Shall the County of Carbon, Wyoming, be authorized to issue general obligation Hospital Bonds of said County in the principal amount of \$335,000.00 bearing interest at a rate or rates not exceeding 6% per annum, payable semi-annually, maturing serially within 20 years from their date, for the purpose of completing the construction and equipping of the County Memorial Hospital in Rawlins, Wyoming?"

Section 6. The County Clerk is hereby authorized to cause a notice and proclamation of the special bond election, to be published in the Rawlins Daily Times, a newspaper of general circulation in the County, and, in addition, in every other newspaper published in Carbon County. Such notice and proclamation shall be published one time between 15 and 25 days prior to the date of the election, and, in addition, in the last issue of each newspaper prior to the election.

Section 7. The Notice and Proclamation shall be signed by the Chairman and attested by the Clerk of the Board of County Commissioners and shall be in substantially the following form:

PUBLIC NOTICE IS HEREBY GIVEN That at a special election to be held in the several election districts and polling precincts in the County of Carbon, on Tuesday, the 29th day of December, 1970, there shall be submitted to the qualified electors of said County, the following question and proposition:

"Shall the County of Carbon, Wyoming, be authorized to issue general obligation Hospital Bonds of said County in the principal amount of \$335,000.00 bearing interest at a rate of rates not exceeding 6% per annum, payable semi-annually, maturing serially within 20 years from their date, for the purpose of completing the construction and equipping of the County Memorial Hospital in Rawlins, Wyoming?"

Persons who are otherwise qualified to vote but who are not presently registered, should register at the office of the Clerk and Recorder of Carbon County, in order that the name of such qualified elector will appear in the official register of voters as maintained by the County Clerk and Recorder.
